Dear Ms Dortch,

My name is Miguel Meléndez and I am the person who applied, in conjunction with Church **Iglesia Refugio, Sanidad y Adoración** (“IRSYA”), for the radio station **WODB LP FM, ID facility #194728**, in the city of Caguas, Puerto Rico. Due to several misunderstandings, the Church does not authorize me with the local FCC, located in San Juan, Puerto Rico, to operate the radio station. In addition, I was dismissed from the functions I performed within the Board of Directors as Secretary and primary contact with the FCC.

With this letter I would like to make you aware that all official documentation associated with the FCC still contains my full name as Secretary and contact representative, even though I have been removed from such duties by the Board of Directors of the Church **Iglesia Refugio, Sanidad y Adoración** (“IRSYA”), and despite that the undersigned, has been a radio personality for more than 30 years. I was the manager and visionary for this radio station project, and in November of 2013 I did not have a non-profit organization, so I applied for the station with the non-profit ownership of the church “**IRSYA**” because it was my lifelong dream.


In addition, I want to inform you that I am the person who provided most of the funds (“**IRSYA**” provided a very minimal sum) to pay for a study of broadcast engineering done by **Mr. Grafton Olivera, - Radio & TV Consulting Engineer at du Treil, Lundin & Rackley**, in Sarasota, Florida, and for the mounting and construction of the radio station, and the station's board, chaired by **Ms. Jacqueline Contés**, removed me from the board of members and disavowed me at the local office of the FCC in San Juan, Puerto Rico, from the operation of **WODB LP FM**.

I, **Miguel Meléndez**, who was the person that brought up to the organization "IRSYA" the idea and vision to apply to the FCC and have the dream of owning a radio station, find myself at the present moment completely out of this radio station project (from April 2016 to present) by decision of the president of "IRSYA" **Mrs. Contés**, which in my understanding, has been very unfair to me.

I spent many hours of work and effort to get this station on the air, searching for equipment prices and consulting with engineers, while the members of "IRSYA" had little concern about this radio station project. Of the six church board members who stand recorded on the application documents before the FCC (Form 318), currently, just the president, Jacqueline Contés, remains. The reason for this is that five of those members, myself included, have left the "IRSYA" organization, and **Mrs. Contés** has not notified the FCC about any of this. The regulation states that if there is a change in the board of directors of more than 50%, the FCC must be notified using form 315 or 316. Presently, this change is at 83.3%.

For this reason, I feel responsible for reporting these and other irregularities as described above.
