

Parties to the Application

FTS is a wholly owned subsidiary of Fox Television Holdings, LLC (“FTH”). FTH, in turn, is a wholly owned subsidiary of Foxcorp Holdings LLC (“Foxcorp Holdings”). Foxcorp Holdings is wholly owned by Fox Corporation (“Fox”).
