

## TIMESHARE AGREEMENT

This Timeshare Agreement is proposed by and among the following applicants for low-power FM stations on 99.1 FM in Los Angeles County, California.

In April 2016, the above named organizations have entered into a voluntary timeshare agreement. With KTPC-LP anticipated to complete construction of its facility by October 2017 and revert to its original share of time, and KZUT-LP in operation, the Timeshare is updated as follows:

1. They shall each broadcast on **Channel 256** in accordance with the schedule attached hereto as Exhibit A. The Parties agree that in accordance with FCC Regulations any change in said broadcast schedule must be agreed to in advance by all parties in writing and said document shall be filed with the FCC prior to the date of any schedule change going into effect.
2. The Parties agree to broadcast programming for more than 10 hours weekly in accordance with the schedule shown below.
3. The Parties agree to amend their respective applications by filing this Agreement with the FCC on or before October **10, 2017**.
4. Each applicant represents that it is duly organized not for profit or educational organization existing and in good standing.
5. To the extent that any information disclosed to any of the Parties hereto which is designated as confidential by the disclosing Party shall be so treated and shall not be disclosed other than to the Parties boards, attorneys or authorized representatives on a need-to-know basis.




