QANTUM OF CAPE COD LICENSE COMPANY, LLC
WRZE (FM) RADIO STATION
DENNIS, MASSACHUSETTS
January 2007

TECHNICAL STATEMENT

1. This technical statement and attached exhibit were prepared on behalf of Qantum of Cape Cod License Company, LLC ("Qantum"), licensee of station WRZE, Channel 242B, Nantucket, Massachusetts. Qantum is submitting a minor change application for WRZE to relocate the station and change the city of license to Dennis, Massachusetts. As such, a radio market analysis is necessary. WRZE's new community of license is located in a metro county in the Cape Cod, Massachusetts Arbitron Market (Market #189). Qantum also owns stations WCIB, Channel 270B, Falmouth, Massachusetts; WCOD-FM, Channel 291B, Hyannis, Massachusetts; and WXTK, Channel 236B, West Yarmouth, Massachusetts. WCIB, WCOD-FM, and WXTK are also licensed to communities in metro counties located in the Cape Cod, Massachusetts BIA/Arbitron Market. As such an analysis for a rated market is needed.

ARBITRON/BIA MARKET REVIEW

2. As shown on Exhibit #1, there are twenty-three AM and FM (commercial and non-commercial) stations listed in the Cape Cod, Massachusetts. Qantum would be in control of four FM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible.

Therefore, control of WRZE, along with three other FM stations, in the Cape Cod, Massachusetts market is believed to be in compliance with the Commission's radio ownership rules for rated markets.

3. As a result of the compliance shown above, in a rated market, the minor change for WRZE is in compliance with the Commission's rules.

4. The foregoing technical statement was prepared on behalf of Qantum of Cape Cod License Company, LLC, by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.2. BIA database. All other data was extracted from the CDBS database. We assume no liability for errors or omissions in either database which may be adverse to the information contained herein.


