² Mr. Behar will serve as a director of HERO Broadcasting Holding Inc. for so long as he serves as President. The remaining three directors will be independent directors (that is, having no material relationship with HERO Broadcasting Holding Inc., any member of its management, or any stockholder). In the event of Mr. Behar's death, his heirs and legatees (provided they continue to own 10% or more of the company's capital stock) will have the right to name a replacement director and the board thereupon will be increased to five members, with the newly-elected president serving as the fifth director. Vacancies in the position of independent director will be filled by persons meeting the qualifications for an independent director that are nominated by the remaining independent directors until such time as all the stock of HERO Broadcasting Holding Inc. shall have been converted to voting stock and existing warrants shall have been exercised.

³ HERO Broadcasting Holding Inc. has two classes of stock, one voting and one non-voting. Mr. Behar holds all of the voting stock of HERO Broadcasting Holding Inc., which amounts to 70.6% of the equity represented by all of the capital stock of HERO Broadcasting Holding Inc.
