Dear Counsel:

This is in reference to the request filed April 6, 2009, on behalf of Mt. Wilson FM Broadcasters, Inc. ("MWFB"). MWFB requests special temporary authority ("STA") to increase the power of its digital signal by 27 percent in order to assess the potential adverse effect of increased digital power on reception of the analog signal. For reasons which are discussed herein, the request is denied.

As MWFB states in its request, a proposal currently is before the Commission in MM Docket No. 99-325¹ to permit an increase in FM digital power from the currently authorized 1 percent of analog power to 10 percent of analog power.² Although a few stations were granted experimental authority to operate for a limited time with increased digital power in order to develop a record in this proceeding, this testing has been completed and the results are currently under consideration by the Commission. The initial test results indicate that, even at a digital power level of 10 percent, there is no significant adverse impact on the host analog signal. Thus, the STA test operation proposed by MWFB is unlikely to add any substance to the record, and grant of the STA request would unduly prejudice the pending proposal in MM Docket No. 99-325. Consequently, we are unable to reach a conclusion that grant of the proposal would serve the
