Dear Mr. Menzer:

This is in reference to the request filed on December 11, 2018. YPBC requests a further extension of the STA granted on April 1, 2016, to continue operating with nighttime parameters at variance to allow time to file the required FCC Form 302 application (due to the required replacement of tower #3).<sup>1</sup> In support of the request, YPBC states that it plans to replace the damaged tower in order to resume licensed operations.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Accordingly, the request for extension of STA IS HEREBY GRANTED, and YPBC may continue to operate at night with DA parameters at variance from licensed values and/or reduced power while maintaining monitor points within licensed limits using the shorter damaged tower #3, with no change to the licensed daytime 5 kW operation (or ND at night with a maximum of 0.25



<sup>1</sup> WOYK(AM) is licensed for operation on 1350 kHz with 5 kW day (ND) and 1 kW night (DA).

kW). YPBC must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310. YPBC must file the application to update all operating parameters, or submit an e-mail to my attention to certify the date the station resumed licensed operations per BL-20131230AVA with negligible changes after replacing the tower with an exact duplicate.

This authority expires on **July 28, 2019**.
