Covenant Network ("Covenant") filed an assignment application with the Federal Communications Commission on January 28, 2016, seeking to assign Construction Permit BNPFT-20130325AIR for unbuilt FM Translator Station K274CF at Monroe City, Missouri (hereinafter the "Construction Permit") to Alpine Broadcasting Corporation ("Alpine") (BAPFT-20160128ANT). Alpine subsequently filed a minor change modification application for K274CF on January 29, 2016 (BMPFT-20160129ANM), which was amended on February 1, 2016 and again on February 2, 2016. The purpose of the modification is to allow Alpine to rebroadcast KCXL (AM), Liberty, Missouri. Upon grant of the modification application, Alpine will build the modified translator promptly.

The Construction Permit currently is scheduled to expire on April 26, 2016. Covenant accordingly requests that the Construction Permit be tolled pursuant to Footnote 36 of the FCC's October 23, 2015 "AM Revitalization" Order, FCC 15-142, for six months from the later of the grant of the above-referenced assignment application or the above-referenced modification application.


