

**RADIO OWNERSHIP ANALYSIS**  
**BALDRIDGE-DUMAS COMMUNICATIONS, INC.**  
**KVCL AM / KVCL-FM RADIO STATIONS**

**TECHNICAL STATEMENT**

This technical statement and attachment were prepared on behalf of Baldrige-Dumas Communications, Inc. ("BDC"), proposed assignee of broadcast stations KVCL, 1270 kHz, and KVCL-FM, Channel 221A, Winnfield, Louisiana. Neither KVCL nor KVCL-FM is licensed to or considered "home" in any Arbitron rated market. Further, as shown on Exhibit #1, the 3.16 mV/m contour of KVCL-FM and the 5.0 mV/m contour of KVCL do not overlap with any of the other stations owned by BDC.<sup>1</sup> Since there is no same service overlap between these two stations, it is believed that ownership of KVCL and KVCL-FM is in compliance with the Commission's ownership rules and regulations.

The foregoing technical statement was prepared on behalf of Baldrige-Dumas Communications, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.0. BIA database. We assume no liability for errors or omissions in the database which may be adverse to the information contained herein.

1) BDC is also the licensee of KDBH-FM, Channel 248A, and KZBL, Channel 264C3, Natchitoches; KWLW, Channel 296C3, and KWLA, 1400 kHz, Many; and KTHP, Channel 280A, Hemphill; and holds an outstanding construction permit for KTEZ, Channel 260A, Zwolle, Louisiana (BLH-20020712ABL). Since there is no contour overlap between KVCL/KVCL-FM and any of these stations, they were not considered in this study.


