**DESCRIPTION OF TRANSACTION, CHANGES IN INTERESTS,
ACQUISITION OF CONTROL, AND MEDIA INTERESTS**

On May 19, 2009, ION Media Networks, Inc. (“ION”) and certain of its wholly owned subsidiaries submitted voluntary petitions to the United State Bankruptcy Court for the Southern District of New York seeking to reorganize under Chapter 11 of the United States Bankruptcy Code. ION also has submitted a motion to consolidate the petitions of the parent and subsidiary entities, and that motion remains pending at this time. *See In re ION Media Networks, Inc. et al.*, Case No. 09-13125 (Chapter 11) (Bnkr. S.D.N.Y.). As a result of the Chapter 11 petitions, ION and its licensee subsidiaries now each operate as a debtor-in-possession under the Bankruptcy Court’s oversight. ION anticipates that each such entity will continue operations in the ordinary course throughout the Chapter 11 process. Exhibit 5 *hereto* provides a copy of the relevant Bankruptcy Court petition.

By this application and concurrently submitted applications, ION seeks FCC consent to the assignment of the FCC authorizations held by ION’s licensee subsidiaries to such subsidiaries as Debtors-In-Possession. Neither the filing of the petitions under Chapter 11 nor the consummation of this and other concurrently filed *pro forma* applications will effectuate a substantial change in control of ION or its licensees. In fact, subject to the jurisdiction and oversight of the Bankruptcy Court, the control of ION has not changed, and the officers of ION and its subsidiaries remain the same. In short, the attributable ownership interests in ION are substantively unchanged from those last approved by the Commission in *Paxson Management Corporation and Lowell W. Paxson (Transferors) and CIG Media LLC (Transferee)*, Memorandum Opinion and Order, 22 FCC Rcd 22224 (2007).

Under the Commission’s policies, the assignment of authorizations to Debtors-In-Possession constitutes a *pro forma* transaction for which the use of FCC Form 316 is appropriate. *See 1998 Biennial Regulatory Review – Streamlining of Mass Media Applications, Rules and Procedures*, 13 FCC Rcd 11349, 11376 & n. 99 (1998) (citing *O.D.T. International*, 9 FCC Rcd 2575 (1994)).
