

AGREEMENT RE AUCTION 1001 APPLICATION

The following memorializes an agreement between Channel 61 Associates, LLC ("Channel 61"), and Cross Hill Communications, LLC ("Cross Hill"), made as of January 5, 2016, regarding the pending assignment of license for television station WNMN, Saranac Lake, New York.

In light of the low likelihood that the Federal Communications Commission ("FCC") will approve the pending application for assignment of the license of WNMN in time to permit consummation of the assignment prior to January 12, 2016, the Channel 61 and Cross Hill agree as follows:

Channel 61 and Cross Hill agree that both wish to relinquish the spectrum occupied by WNMN in the FCC's reverse spectrum auction (Auction 1001).


Channel 61 will file an application to participate in the FCC's reverse spectrum auction.

Channel 61 and Cross Hill agree that upon consummation of the planned assignment of the FCC license for WNMN to Cross Hill, Cross Hill will use the FRN and password of Channel 61 associated with WNMN as of December 8, 2015, for purposes of continuing to prosecute Channel 61's auction application and participating in the reverse auction with respect to WNMN.

Channel 61 and Cross Hill acknowledge that the FCC is not liable for their use of any FCC systems or information accessed as a result of a shared FRN and password.

Upon consummation of the assignment of license, Cross Hill agrees to be bound by Channel 61's actions in the auction, if any, with respect to Station WNMN, to the same extent and in the same manner as Channel 61 would be bound.
