*Barbara Laurence*

Barbara Laurence currently holds a voting interest and an indirect ownership interest in SATV10, LLC, licensee of KTRG(TV), Del Rio, TX (FacID 55762). On August 20, 2007, the Commission granted an application requesting a *pro forma* transfer of control of KTRG(TV) from Barbara Laurence, individually, to SLN Management Group, LLC ("SLN"), a Delaware limited liability company. Barbara Laurence holds 100% of the common unit votes and 70% of the total assets of SLN, which in turn holds 100% of the votes and 50% of the assets of SATV10, LLC.

Barbara Laurence is a director and member of Welshman 1210, LLC, a Florida limited liability company, that holds a 49% voting interest in Cranston II, LLC, a Delaware limited liability company. Cranston II, LLC is a sole member and 100% owner of Cranston Acquisition, LLC, a Delaware limited liability company and licensee of KMCC (TV) in Laughlin, NV (FacID 41237).

Bela TV, LLC, a Florida limited liability company ("Bela-TV") is the licensee of KBEH (TV), Oxnard, California (FacID 56384) and KBEH1, Los Angeles, California (FacID 134300). The sole member of Bela TV is Bela Broadcasting, LLC, a Florida limited liability company ("Bela Broadcasting"). Cranston, LLC ("Cranston") holds a 44% Common Membership interest and a 2.76% Series B Preferred Membership interest in Bela Broadcasting. Barbara Laurence is Senior Executive Vice President and a director of Bela Broadcasting and is Chairman of the Board and President of Cranston.

Phoenix 6 TV LLC ("Phoenix TV") is the licensee of KMOH-TV, Kingman, Arizona (FacID 24753). The sole member and 100% owner of Phoenix-TV is Phoenix 6 Broadcasting LLC ("Phoenix Broadcasting"). The sole member and 100% owner of Phoenix Broadcasting is Bela Broadcasting. The interests in Bela Broadcasting of Cranston and those of Barbara Laurence are set forth above.

Barbara Laurence is Vice President and Member of the Board of Managers of TV Plus, LLC ("TV Plus") and is President, Chairman and a Member of the Board of Directors of LATV Partners, LLC. LATV Partners, LLC holds a 20% membership interest in TVPlus, which in turn holds a 7% interest in Initial Broadcasting of California, the licensee of KHIZ (TV), Barstow, California (FacID 63865). TVPlus has contractual rights to enter into a time brokerage agreement for the station.

Barbara Laurence is President, Chairman and a Director of Canal Plus, LLC, the proposed assignee of KBNB-LP, San Antonio, TX. (FacID 58690).

Seth Kanegis is the sole LLC member of Special K Investors, LLC, which is the 50% owner of SATV10, referenced above.

Seth Kanegis holds a 3% interest in LATV Partners, LLC, referenced above.
