Lehigh Valley Community Broadcasters Association, Inc. (“Lehigh”), licensee of Noncommercial Educational Station WDIY(FM-NCE), Allentown, Pennsylvania is a non-stock, non-profit Pennsylvania corporation. Lehigh is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of Lehigh’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The FCC last approved the board of Lehigh in FCC File No. BTCED – 20100326ACC, which was granted April 19, 2010. The changes to the members of the Board of Directors since that time are set forth in the chart below.

No consideration or thing of value is being given in exchange for the interests being transferred. All current Board Members are U.S. citizens. None have any interests in any mass media other than their interest in the licensee.
