
Dear Applicant:

This letter refers to the above-captioned application for W201DK, Waycross, Georgia.

An engineering study reveals the application is a major change pursuant to Section 74.1233(a)(1) of the Commission's Rules. Specifically, the proposed 60 dBu service area fails to provide service to some portion of its 60 dBu licensed service area, (BLFT-20090304ACN). Therefore, the proposal is a major change. Because major change applications are not being accepted for filing, the application will be dismissed.

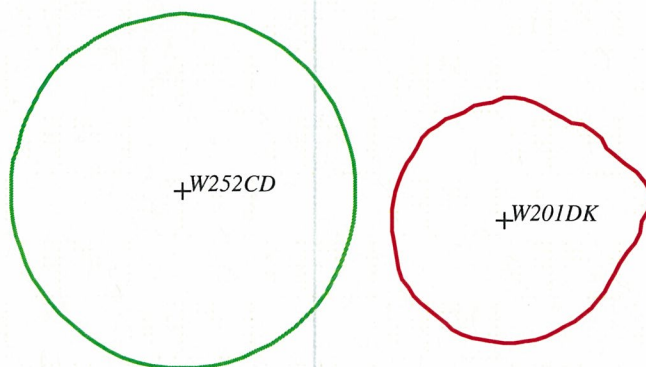
