

Description: DTV CONSTRUCTION STATUS

THIS STATION COMPLETED CONSTRUCTION OF ITS FINAL DTV FACILITIES PRIOR TO ITS ORIGINAL MAY 18, 2008 DEADLINE. HOWEVER, WHEN IT ATTEMPTED TO FILE THE INSTANT UPDATE, CDDBS PREVENTED THE FILING, CITING AN INABILITY TO ACCEPT A CONSTRUCTION DEADLINE IN THE PAST. ACCORDINGLY, THE RESPONSE TO SECTION II, ITEM 3 HAS BEEN CHANGED TO REFLECT A DATE IN THE FUTURE -- THE NATIONWIDE DTV TRANSITION DEADLINE OF JUNE 12, 2009 -- WHEN THE STATION INTENDS TO TERMINATE ANALOG SERVICE AND COMPLETE ITS DTV TRANSITION.
