

## **Technical Report W249AH Minor Modification**

This technical report is submitted for a minor modification to W249AH at Johnson City, TN, FCC file no. BLFT-20080422ABD. Changes in antenna and ERP are requested. The translator is to serve as a fill-in to rebroadcast the WTFM(FM) 253C primary signal at Kingsport, TN, FCC facility I.D. 27489.

### **W249AH Modification Analysis:**

An overlap study (exhibit E-1) shows the W249AH modification will not produce any interference overlap to current facilities.

The translator will remain on the current tower, ASR 1043907, at coordinates:

**36 16 07N 82 20 21W NAD 27.**

Two Scala CA2-FM vertically-polarized directional antennas, rotated at 300 and 90 degree azimuths with a 75, 25% power split, respectively (exhibits E-2 and E-3) will be mounted at a COR AGL of 28 meters, 1006 meters AMSL at a HAAT of 388 meters, calculated using the CONTOUR program with the FCC 30 second terrain data with 12 radials, and operate at 0.250 kW ERP. The W249AH modification 60 dBu F(50-50) contour is completely contained within the primary WTFM(FM) 60 dBu contour, and overlaps the current W249AH 60 dBu contour (exhibit E-4).

### **RF Exposure Calculation:**


The RF contribution was calculated using the formula from the OET Bulletin 65:

$$S \text{ (RF in microwatts/cm}^2\text{)} = \frac{33.4 \times F^2 \times (H \text{ ERP} + V \text{ ERP in watts})}{R^2 \text{ (distance to radiation center in meters -2m)}}$$

Using a vertical (F) factor of 0.595 at a 45 degree depression angle from the antenna elevation pattern, the RF is calculated to be  $4.37 \mu\text{W}/\text{cm}^2$  to the ground, which is well below 5% of the  $200 \mu\text{W}/\text{cm}^2$  maximum permissible for general public exposure allowing exclusion from consideration.

**Conclusion:**

It is concluded that the W249AH modification complies with all Commission rules and policies.






