
Re: Request for Correction to Licensee Names & Licenses

The stations below are recorded in CDBS as being licensed to Grace Christian Church of Amarillo, Inc. The correct name is Grace Community Church of Amarillo. A Form 314 was filed for the stations in which the assignee name was incorrect (see File No. BALED-20080925AAG). All attachments in that application related to the assignee did contain the correct assignee name (see Attachs. 5, 14, and 16). Subsequent filings for the facilities did use the correct licensee name. The licenses for the stations contain the wrong licensee name and need to be re-issued with the correct name, Grace Community Church of Amarillo.
