

**AMENDED Exhibit 1 SCRIPPS HOWARD BROADCASTING CO July 1, 2002  
LISTED BY SECTION AND QUESTION NUMBER ARE THE MODIFICATIONS TO  
THE KSHB-DT KANSAS CITY MISSOURI EXISTING CONSTRUCTION PERMIT**

**REASON FOR MODIFICATIONS**

This instant application for KSHB-DT Channel 42 is one of four television channel applications being submitted at this time.

Each of the four Scripps Howard Broadcasting Company (SHBC) applications request location on a common tower. The use of this common location meets channel distance separation requirements to each of the other three SHBC channels and to all other known channel licenses and assignments. Each SHBC channel provides the required Principal City coverage. The channels to be located on the same tower include:

Scripps Howard Broadcasting Company (SHBC) has completed the acquisition of property (which was not available until recently) for a new 354.8 meter tower (registration number 1234587) under contract with Central Tower. It is necessary for SHBC to construct a tower because placement of channels 36, 38, and 42 on existing or other planned towers was thwarted. It is necessary to move presently sited channel 41 with 42 to meet channel separation requirements.

**AMMENDMENTS**

This second page added to Exhibit 1, is being provided as an amendment in order to correct typographical errors and remove Exhibit 39 which was inadvertently left in this instant application from the earlier construction permit application for channel 42.

Information has also been added in Exhibit 41 relative to K27FR since this translator may appear as an interference issue. Although K27FR was eligible for Class A status, it could not be found that K27FR has Class A status or that an application for class A status was ever submitted to the FCC.

In the first line of Exhibit 41, **“KMCI-DT channel 36”** should read **“KSHB-DT channel 42”**,

The Section III-D, §10 e. “box” should not be checked. The antenna is directional and the field values for the antenna were filed with the application.
