Exhibit 1 – Contingent Applications and Mutual Consent Agreement

The instant application is being filed concurrently with, and contingent upon, an application for a minor change in the facilities of KCSI(FM), Red Oak, Iowa, Fac. ID 26456 pursuant to Section 73.3517(e) of the Commission's rules. Station KCSI is licensed to Hawkeye Communications, Inc ("Hawkeye"). Among other changes, the minor change application for KCSI requests a change in community of license for the station, from Red Oak to Treynor, Iowa.

A copy of the agreement underlying this coordinated effort, the Mutual Consent Agreement by and between Chapin Enterprises, LLC ("Chapin Enterprises"), as successor-in-interest to Three Eagles of Lincoln, Inc. ("Three Eagles"), and Hawkeye, is attached hereto as Exhibit 1 (the "Agreement"). Chapin Enterprises assumed the Agreement when it consummated the assignment of KRKR(FM), Lincoln, Nebraska, Fac. ID 54707 from Three Eagles.

## **EXHIBIT 1**

### **MUTUAL CONSENT AGREEMENT**

This Mutual Consent Agreement (the "Agreement") is made as of April \_\_, 2007 by and between Three Eagles of Lincoln, Inc. ("Three Eagles") and Hawkeye Communications, Inc. ("Hawkeye").

WHEREAS, Three Eagles is the licensee of KRKR(FM), Lincoln, Nebraska, Fac. ID 54707;

WHEREAS, Hawkeye is the licensee of KCSI(FM), Red Oak, Iowa, Fac. ID 26456; and

WHEREAS, Three Eagles and Hawkeye desire to jointly consent to mutual contingent minor changes to the facilities KRKR and KCSI.

NOW THEREFORE, upon the mutual promises and covenants made herein, the parties hereto agree as follows:

1. Three Eagles hereby agrees to request a minor modification of KRKR's licensed facilities to change the station facilities to Class A; change the station's channel to 236; reduce effective radiated power ("ERP") to 6.0 kilowatts; relocate the station's transmitter site to the location represented by the coordinates 41° 16' 06.0" N, 096° 11' 39.9" W (NAD-27); increase the antenna radiation center height above average terrain ("HAAT") to 100 meters and change KRKR's community of license to Valley, Nebraska, all contingent upon Hawkeye's agreement to change the facilities of KCSI as set forth in Section 2 hereto.

2. Hawkeye hereby agrees to request a minor modification of KCSI's licensed facilities to increase ERP to 22.5 kilowatts; relocate the station's transmitter site to the location represented by the coordinates 41° 14' 43.0" N, 095° 41' 32.2" W (NAD-27); increase the antenna radiation center HAAT to 105 meters and change KCSI's community of license to Treynor, Iowa, all contingent upon Three Eagles' agreement to change the facilities of KRKR as set forth in Section 1 hereto.

3. The parties hereby agree to coordinate and concurrently file with the Federal Communications Commission ("FCC") applications to modify the facilities of their respective stations as set forth herein. Three Eagles and Hawkeye agree that other than the exchange of promises, no other consideration, including monetary consideration, will be due to or from either party.

4. Each party agrees that no change in facilities shall be effectuated by either party unless and until the FCC has granted both parties' applications.

5. This Agreement shall be assignable by the parties, to their respective heirs, successors and assigns, upon the written consent of the other party, which consent will not be unreasonably withheld.

6. This Agreement can be signed in counterparts such that two separately signed copies of this Agreement shall constitute one agreement.
