This amendment reflects the fact that Great Plains assigned its license for Dalhart, Texas (K201HN, Facility I.D. 122163) to Dalhart Community Radio (BALFT-20080428ACB), so that application has been removed from the current list of licensed translator stations. Great Plains previously reported that its applications for construction permits for NCE FM stations at Chanute, KS, Boise City, OK and Guymon, OK (listed above under “Construction Permits”) were granted.
