

## CHANGES IN INTEREST

As the Commission's records reflect, on December 20, 2009, Citadel Broadcasting Corporation ("Citadel") and the subsidiaries of Citadel that hold broadcast licenses (the "Citadel Licensee Subsidiaries" and together with Citadel, the "Debtors"), filed voluntary petitions for bankruptcy seeking relief under the provisions of Chapter 11 of the Bankruptcy Code to effectuate a restructuring of the debt obligations of the Debtors with the United States Bankruptcy Court of the Southern District of New York ("Bankruptcy Court"). Accordingly, the Debtors are now operating as debtors-in-possession under the Bankruptcy Court's oversight. On December 22, 2009, the Debtors filed applications with the Commission seeking consent to the *pro forma* assignment of the Citadel Subsidiaries' FCC licenses from the Citadel Licensee Subsidiaries to the Citadel Licensee Subsidiaries as debtors-in-possession.<sup>1</sup> The FCC granted those applications on December 30, 2009.

Upon the filing of the Chapter 11 Joint Plan of Reorganization (the "Plan"), as modified, with the Bankruptcy Court, applications were filed on FCC Form 315 on March 18, 2010, requesting Commission consent to the transfer of control of the broadcast radio station licenses held by the Citadel Licensee Subsidiaries, as debtors-in-possession, from the existing shareholders of Citadel to the shareholders of Citadel Broadcasting Company, as Reorganized (the surviving company after the reorganization described in the Plan) (hereinafter "CB Company").<sup>2</sup> Those applications remain pending. Until grant of the transfer of control applications, the attributable ownership interests in Citadel are substantively unchanged from those last approved by the Commission in *Citadel Broadcasting Co. and The Walt Disney Co. (Transfer of Control)*, Memorandum Opinion and Order and Notice of Apparent Liability, 22 FCC Rcd 7083 (2007); accordingly, the contemplated assignment is *pro forma* in nature.

The Chapter 11 Plan contemplates that, on and after the effective date of the Plan, Citadel will merge with and into CB Company, with CB Company as the surviving entity. The assets of Citadel shall be transferred to CB Company and new common stock and special warrants in CB Company shall be issued. Each of the Citadel Licensee Subsidiaries shall continue to exist after the effective date as a separate entity.

Accordingly, by a series of concurrently-filed applications, each of the following Citadel Licensee Subsidiaries requests FCC consent to assign its licenses from the debtor-in-possession entity listed below (and approved in the application numbers listed in Footnote 1) to the corresponding Citadel Licensee Subsidiary that will ultimately hold the FCC licenses for the stations listed below upon approval of the Plan by the Bankruptcy Court and the company's reorganization and emergence from bankruptcy.
