In evaluating the proposed NEW low-power digital television station, an outgoing interference study was executed on the proposed design in the attached application using the OET-69 Longley Rice methodology. The stations listed in the table below showed possible interference. When these stations were evaluated for outgoing interference, there was zero percent interference present found in each case when rounded to the nearest whole percent.
