

## EXHIBIT 12

WNJX-TV, Inc. holds the license of WNJX-TV, Mayaguez, Puerto Rico. Upon Commission approval of the transfer of control of WNJX-TV, Inc. from LIN Television Corp. to InterMedia Partners, VII, L.P. ("InterMedia Partners VII"), WNJX-TV, Inc. will be an indirect wholly owned subsidiary of InterMedia San Juan, Inc., and a direct wholly-owned subsidiary of LIN Television of San Juan, Inc.<sup>1</sup> By the *pro forma* transfer of control contemplated in this application, InterMedia San Juan, Inc. will merge with and into LIN Television of San Juan, Inc., and subsequently LIN Television of San Juan, Inc. will merge with and into Televiscentro of Puerto Rico, LLC ("Televiscentro"). In a contemporaneous *pro forma* assignment, WNJX-TV, Inc. will merge into and with Televiscentro of Puerto Rico, LLC, which will then be the licensee of WNJX-TV. A FCC Form 316 for the WNJX-TV/Televiscentro *pro forma* assignment is being filed concurrently with the instant form.

S&E Network, Inc., which will become a wholly owned subsidiary of InterMedia Puerto Rico Holdings, LLC upon Commission approval of the transfer of control of S&E Network, Inc. from LIN Television Corp. to InterMedia Partners, VII, holds Commission licenses for WJPX(TV), San Juan, Puerto Rico, WKPV(TV), Ponce, Puerto Rico, and WJWN-TV, San Sebastian, Puerto Rico.<sup>2</sup>

Jeff Sagansky, an attributable investor in InterMedia Partners, L.P., sits on the board of directors of The E.W. Scripps Company, which wholly owns the Scripps Howard Broadcasting Company and Scripps Shop At Home, Inc. According to an FCC Form 323 Ownership Report filed by the Scripps Howard Broadcasting Company, *see* File No. BOA- 20050601AUY, the following television broadcast stations are attributable to The E.W. Scripps Company:<sup>3</sup>
