

### Explanation of Transaction

The instant application seeks the Commission's consent to the assignment of the licenses of stations KXRM-TV and KXTU-LD, Colorado Springs, Colorado, and K28GE, Woodland Park, Colorado, from KXRM Licensee, LLC to LIN Television Corporation.

This application is one of nine applications being filed contemporaneously which are related to and contingent upon consummation of the pending merger (the "Merger Transaction") of Media General, Inc. ("Media General") and LIN Media, LLC ("LIN"). Upon consummation of the Merger Transaction, the combined company would hold television station license combinations exceeding those permitted under Section 73.3555 of the Commission's Rules in five Nielsen DMAs. LIN and Media General have therefore committed to divest interests in each of these five markets: Birmingham (Anniston & Tuscaloosa), AL; Green Bay – Appleton, WI; Mobile, AL – Pensacola, FL; Providence, RI – New Bedford, MA; and Savannah, GA.

The nine applications represent a combination of (i) required divestitures by (post-merger) Media General in the above markets, (ii) the sale of additional stations to certain divestiture station buyers that are not legally required for the Merger Transaction, but which are part of the divestiture transactions, and (iii) the purchase by (post-merger) Media General of stations from certain divestiture station buyers to accomplish like-kind station "swaps" for stations being divested by (post-merger) Media General.<sup>1</sup> The stations for which assignment applications are being filed contemporaneously are set forth in the table below.

in the operation of WTGS(TV), and the exercise by LIN Television Corporation of an outstanding option to acquire WTGS(TV) under which WTGS Television, LLC will assign the station's licenses and other assets directly to WTGS Licensee, LLC.
