Request for Waiver 47 C.F.R. Sections 74.705, 74.706 & 74.707

The existing K66BE and proposed channel 11 translator site is located on a hill 0.75 km East of Bell Mountain in Douglas County, Oregon. The area surrounding the antenna site is very hilly and mountainous although the antenna site itself is line-of-sight to the community of Elkton.

A complete allocation study was performed for the proposed channel 11 translator and, with five exceptions, complies with all of the contour protection requirements of 47 C.F.R. Sections 74.705, 74.706 and 74.707. The protected contours for all of the five exceptions noted below are completely terrain shielded from the proposed channel 11 antenna center of radiation. The licensees and permittee of these five stations acknowledge this terrain shielding and have given their assent to grant of a terrain waiver to permit the Applicant to continue to operate the K66BE translator on the new channel 11 with an effective radiated power of 0.037 kW.

Exhibit No. 6A is the Assent to Grant of Terrain-Waiver signed by the licensee of channel 11 TV Station KCBY at Coos Bay, Oregon.

Exhibit No. 6B is the Assent to Grant of Terrain-Waiver signed by the licensee of channel 12 TV Station KDRV at Medford, Oregon.

Exhibit No. 6C is the Assent to Grant of Terrain-Waiver signed by the licensee of translator K11GT at College Hill, Oregon.

Exhibit No. 6D is the Assent to Grant of Terrain-Waiver signed by the licensee of translator K11KI at Dorena, Oregon.


The Applicant, Oregon Public Broadcasting, is also the permittee for a DTV construction permit on channel 11 at Bend, Oregon. OPB proposes to operate KOAB-TV DTV with an antenna power of 160 kW ERP. Studies show there is presently no prohibited overlap of the interfering channel 11 translator contour with the noise-limited service contour of KOAB-TV. However, in the event such overlap should arise, Exhibit No. 6E is the Assent to Grant of Terrain-Waiver signed by the permittee of DTV Station KOAB-TV at Bend, Oregon.

The undersigned representative for Fisher Broadcasting, Inc., licensee of channel 11 (zero offset) TV Station KCBY at Coos Bay, Oregon, understands that Oregon Public Broadcasting (OPB) desires to change the operating channel of their existing TV Translator Station K66BE at Elkton, Oregon to channel 11 (minus offset) and that the antenna effective radiated power will be 40 watts or less. Significant terrain shielding does exist in the intervening area between the K66BE(11) antenna and the KCBY service area.

Therefore, the undersigned representative believes no interference to the protected service area of KCBY will occur and does agree to and give expressed assent to a grant of a terrain-waiver of 47 C.F.R. Section 74.705 to permit OPB to operate their K66BE translator station on channel 11. This assent is granted only if no interference from the proposed K66BE(11) is caused and does not surrender any rights to protection from any actual interference which may subsequently arise.
