## **STATEMENT OF EDUCATIONAL OBJECTIVES**

Horizon Christian Fellowship (“Horizon”) is a non-denominational church located in Fitchburg, Massachusetts. Horizon is a not-for-profit corporation that has tax exempt status under Section 501(c) of the Internal Revenue Code.

Horizon conducts educational and instructional programs for its members as well as the greater Fitchburg community. Among those programs are:

- Regular bible study classes, including special men’s and women’s classes, and home study classes.
- Youth classes directed at helping young people deal with some of the most challenging issues they face.
- Parenting seminars with additional classes made available on DVD to interested persons.
- Addict ministries aimed at discouraging drug and alcohol abuse by teaching positive values.
- Marriage and family seminars and counseling, done periodically with groups or individual couples.
- Disaster relief training such as Critical Incident Stress Management (CISM) and practical training.
- Compassion programs with the focus of caring for those in prison, youth detention centers, hospitals and nursing homes.
- Cross-cultural and international ministry and training that introduces people to other languages and cultures.
- Retreats and conferences centered on religious educational themes.

- Radio program syndication (to stations in Connecticut and Maine).
- Twice weekly educational TV program on greater Fitchburg public access cable TV, featuring current topics of interest to the faith-based community.
- Bookstore and lending library that carries a wide variety of study material, books, videos, music CDs and tapes.

Horizon's goal in acquiring a radio station is to expand its educational outreach to and beyond the Fitchburg area, most immediately to Cape Cod, Massachusetts. That region will be served not only by the Wellfleet station, but also by strategically-placed translators. Having a full-time radio outlet will enable Horizon to advance its educational objectives, reflected in the initiatives outlined above, through putting its considerable talents and capabilities to work in a much broader arena.
