TECHNICAL STATEMENT

This technical statement and attached exhibits were prepared on behalf of Capital Media Corporation (CMC), as part of the modification of the current construction permit for WBAR-FM, Lake Lucerne, NY.

The instant application for modification has no impact on ownership levels, competition issues nor does it precipitate any overlapping contours between CMC stations.

Capital Media owns five stations in the upstate New York region :

Coverage in the area of Glens Falls, NY

WBAR-FM	Lake Luzerne, NY
WMNV	Rupert, VT

The above 'market' is unrated. The 70 dbu (city grade) contours of these two stations (modified CP of WBAR-FM and licensed facility of WMNV) do not overlap. There are 9 other stations owned by other licensees within 30 kms of WBAR-FM. There are a total of 15 owned by others within 30 kms of both stations.

In this situation an owner may have 'a cognizable interest in up to 5 commercial full-power radio stations, not more than 3 of which are in the same service (AM or FM)'.

CMC's ownership level is below these limits.

Coverage in and part of the Albany-Schenectady-Troy, NY rated market # 63

WHAZ-AM Troy, NY
WHAZ-FM Hoosick Falls, NY
WMYY-FM Schoharie, NY

Regards these three stations, the Albany-Schenectady-Troy, NY, metro ADI as reported by BIA has 50 or more (inclusive) "home" commercial and noncommercial educational full-power radio stations. In this situation an owner may have ' a cognizable interest in up to 8 commercial full-power radio stations, not more than 5 of which are in the same service (AM or FM)'. None of the above three stations have overlapping city grade coverage with each other nor with any of the Glens Falls area stations.

This application complies with the local radio ownership.

All data relating to AM and FM facilities was extracted from the CDBS database.
