

### **Changes in Interests**

Legal control of Gannon University (“Gannon”) resides with the Board of Trustees. The instant application is being filed to notify the Federal Communications Commission of the gradual change in the membership of the Board of Trustees of Gannon and to obtain FCC consent for the current membership. Noncommercial licensees may be required to request Commission approval if membership of the controlling body of the licensee is changed by more than 50%, even if that change is incremental. This application is being filed to report the gradual change in control.

As is typical of non-profit, noncommercial educational licensees, the composition of the Board has gradually changed over the years. The table at pages 15-16 demonstrates that the change in the composition of the Board has occurred gradually since 2012, when the FCC last approved a transfer of control of Gannon (File No. BTCED-20120326ABH). Accordingly, the use of Form 316 is appropriate for this application.

No written agreements exist for documenting the changes herein listed, as they occurred through the ordinary process of attrition and appointment of new board members. No consideration or thing of value has been given or promised in exchange for the changes in the Board’s composition. All board members are U.S. citizens.

Below is a list of the old members of Gannon the last time the FCC approved a pro forma transfer of control of Gannon, followed by the new members and then the table showing the gradual change in the composition of the Board.
