
ENGINEERING STATEMENT
IN SUPPORT OF APPLICATION FOR MODIFICATION OF LICENSE
RADIO STATION KXKZ(FM)
RUSTON, LOUISIANA

This Engineering Statement was prepared in support of an Application for Modification of License for KXKZ(FM), Ruston, Louisiana, concerning a correction of the geographic coordinates of the transmitter site pursuant to Section 73.1690(c)(11) of the FCC Rules. KXKZ(FM) is licensed for operation on Channel 298C with a nominal non-directional ERP of 100 kW and an antenna HAAT of 325 m.

This application is required to harmonize the KXKZ(FM) licensed transmitter site coordinates with the FCC Antenna Structure Registration information for the KXKZ(FM) tower.* No other changes are contemplated.

The corrected coordinates of the KXKZ(FM) transmitter site in NAD 27 datum, rounded to the nearest second, are as follows:

North Latitude (NAD 27)	32°26'37"
West Longitude (NAD 27)	92°42'43"

This represents a 1-second change in both latitude and longitude from the presently licensed values.

The KXKZ(FM) facility, as presently licensed, is not short-spaced with any other facilities pursuant to the requirements of Section 73.207 of the FCC Rules. As

outlined in the attached Figure 1, the coordinate correction will not result in the creation of any short-spacings and the KXXKX(FM) facility will remain fully-spaced.
