Description of educational program and how the proposed station will be used to advance the educational program.

The People's Press Project Education Program

The People's Press Project (also known as PPP) was created as a new organization in April 2010 to address the lack of media access and equity in rural ND and MN. The PPP, which is located in Moorhead on the border of Minnesota and North Dakota in the region known as the Fargo-Moorhead (F-M) metro area, has been uniquely positioned to have great impact to activate and engage community in media access and justice issues in the region. PPP Incorporated as a Minnesota State Nonprofit in May of 2010 and received its nonprofit status from the IRS in May of 2012. The PPP is Fargo-Moorhead's only non-profit dedicated to empowering the community to impart media, rather than being consumers of media.

The PPP's vision is based on the power of media to engage disenfranchised communities to inform the public and engage them in democracy; and transform community discussions. PPP believes that its is a human right for members of a community to share equally in their ability to access media and be equally represented in it; that accessing media is crucial to movement building; and that equal access to communication is necessary to achieve social change.

Media Access Project is a set of trainings are designed to educate, inform, and empower the people in the community to have greater access to media and teach them to effectively communicate their important issues to others and how to effectively access media so they can tell their stories. This educational program has elevated disenfranchised communities ability to become more engaged in the community by giving them greater access to local democracy and assist them in reaching their full participation. This education program has trained individuals to attract media attention, create and define media, and use media technology. The curriculum has been provided free of charge to the regional community and encompasses training and hands on production in audio, film, web production, media analysis, journalism and the study of communication.

How the Proposed Station will be used to advance the Education Program

The proposed low power radio station will be located in Fargo and has an anticipated reach of 2-5 miles. Our focus will be on immigrant communities, communities of color, low income people and students. Any and all community involvement will involve training in broadcasting, radio show programming, computer skills and internet training. Business management will also be an area where station constituents will learn marketing, fundraising and proponents of business management and the radio industry.

The educational program and individual skill development by PPP will be utilized through the proposed radio station to create equity in communication/media/information for all members of the community to equally share in the cities development. PPP's organizing and training programs will be enhanced and furthered through the operation of the proposed radio station. The use of radio production and programming will result in the immediate impact of an engaged community and the benefits of communication rights and multi-media access/skills to traditionally disenfranchised communities (immigrants, new Americans, communities of color, LGBTQ, people with disabilities, youth, blue collar and working poor, rural communities, single parent households, homeless, elderly, etc.), as well as students, nonprofits, small businesses, artists, and new journalists. Having a radio station combined with the training program will have a beneficial impact on the community by putting community members in the driver's seat of their own media production.

The proposed low power FM station will advance the People's Press Project's educational programs by broadcasting:

- Artistic Expression events
- International news
- Faith communities
- Local news
- Local Live Music
- Ethnic music and ethnic news
- Governmental meetings audio rebroadcasts
- Comedy, live stand-up Open mic sessions
- Storytelling production
- Sports reporting

- Churches issues, news and announcements
- Opinion talk radio
- Live Interviews


Dear Applicant:
