The members of Archway are Quetzal/J.P. Morgan Partners, L.P. ("Quetzal"), Lauren M. Tyler, Reginald J. Hollinger, Alcides Pina Vicente, Dennis Roy Moore, Patricia Sullivan, Brian Krysz and Christopher Fleming. Quetzal holds 73.5% of the voting and equity interests in Archway and the assignee, and Mr. Vicente holds 17% of the voting and equity interests in Archway and the assignee. Ms. Tyler and Mr. Hollinger are responsible for voting Quetzal's 73.5% interest in Archway and the assignee. No other person or entity directly holds more than 5% of Archway's equity or voting interests. The members of Archway's Board of Managers are Reginald J. Hollinger, Lauren M. Tyler, Alcides Pina Vicente, and Dennis Roy Moore.

Quetzal is a Delaware limited partnership whose sole general partner is Quetzal/J.P. Morgan Partners (GP), LLC ("Quetzal/JPMP"). Quetzal/JPMP controls the voting interests of Quetzal and has a less than 1% equity interest in Quetzal. Quetzal has 17 insulated limited partners who collectively hold 70.50% of Quetzal's equity interests, and one non-insulated limited partner, Chatham Ventures Inc., which holds a 29.5% equity interest.

Quetzal/JPMP is a Delaware limited liability company, whose managing members are Reginald J. Hollinger and Lauren M. Tyler, who respectively hold (subject to several variables, including vesting) 27.5% and 23.0% interests in Quetzal/JPMP. Quetzal/JPMP has three non-managing members, only one of whom, JPMP Master Fund Manager, L.P., has a greater than 5% interest. JPMP Master Fund Manager, L.P. holds a 49.5% interest in Quetzal/JPMP and has no officers or directors.

Chatham Ventures, Inc., a Delaware corporation, is a wholly-owned subsidiary of J.P. Morgan Chase & Co. Chatham Ventures, Inc. has one director, William B. Harrison, Jr., and has the following 7 officers, all of whom are United States citizens:

JPMP Master Fund Manager, L.P., a Delaware limited partnership, has one general partner, JPMP Capital Corp., which controls 100% of the vote of JPMP Master Fund Manager, L.P. and holds 25% of its equity. Limited partners hold the remaining 75% of the equity, with four individuals (Jeffrey C. Walker, Michael J. Blutt, Arnold L. Chavkin, and John M.B. O'Connor) holding 5% or more (their actual equity interests are not readily determinable because they are subject to several variables, including JPMP MFM's internal rate of return and vesting).

JPMP Capital Corp., a New York corporation, is a wholly-owned subsidiary of J.P. Morgan Chase & Co. JPMP Capital Corp. has two directors, William B. Harrison and Jeffrey C. Walker, both of whom are United States citizens, and has the following 36 officers, all but two (Mr. Irigoin and Mr. Soghikian) of whom are United States citizens:
