### Summary

A study was performed in order to evaluate a proposed modification of the current authorization of WBVL-LP.

The proposed modifications entail a site move to 28-19-47.48 N, 81-25-4.13 W (NAD 27), as well as a change in antenna HAAT to 30.0 m.

---

### Affirmation

WBVL-LP operation under the proposed modification would be fully compliant with §73.807 minimum separation requirements with respect to all co-channel, first-adjacent channel, and second adjacent channel stations (Exhibit 8a) and, as a result of this, no interference study is required in this request for modification. The modification would increase the population within WBVL-LP's 60 dBu service area from 58,286 as currently permitted to 80,067, and would increase the population within the 54 dBu contour from 88,216 as currently permitted to 142,787.


