TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Cumulus Media Inc. in connection with the proposed transfer of control of Cumulus Licensing LLC ("Cumulus"). Cumulus is the licensee of KBED, 1510 kHz, Nederland, Texas; KIKR¹, 1450 kHz, KQXY-FM², Channel 231C1, and KTCX, Channel 273C2, Beaumont, Texas; KAYD-FM, Channel 269C3, Silsbee, Texas; and KSTB, Channel 268A, Crystal Beach, Texas. Cumulus has an attributable in CMP KC Licensing, LLC, the licensee of KHJK, Channel 279C, La Porte, Texas and KFNC, Channel 248C, Beaumont, Texas³, and KRBE Lico, Inc., the licensee of KRBE, Channel 281C, Houston, Texas.

- 1) KIKR also holds a construction permit to correct coordinates (BP-20090924ABG) and will remain a metro station.
 - 2) KQXY-FM also holds a construction permit to relocate (BPH-20090317ADH), but will remain a metro station.
 - 3) KFNC also holds a construction permit to change community of license at its existing site (BPH-20090520ACZ). The new community of license is Mont Belvieu, Texas. Implementation of this change of community will make KFNC a metro station in the Houston-Galveston, Texas market and remove it as a metro station in the Beaumont-Port Arthur, Texas market. It is noted that KFNC is presently considered "home" in the Houston-Galveston, Texas market.

2. KIKR, KBED, KQXY-FM, KAYD-FM, KFNC, and KTCX are licensed to communities in a metro county in the Beaumont-Port Arthur, Texas Arbitron Market. KSTB, KRBE, and KHJK are licensed to communities in a metro county in the Houston-Galveston, Texas Arbitron Market. KFNC is also considered “home” to the Houston-Galveston, Texas market. Therefore, this review will verify compliance of commonly owned stations in rated markets.

HOUSTON-GALVESTON, TEXAS MARKET

3. As shown on Exhibit #1, there are 76 AM and FM (commercial and non-commercial) stations listed in the Houston-Galveston, Texas Arbitron Market (Market #6). Cumulus controls four FM stations in the market. The number of stations indicated falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Houston-Galveston, Texas market.

BEAUMONT-PORT ARTHUR, TEXAS MARKET

4. As shown on Exhibit #2, there are twenty-seven AM and FM (commercial and non-commercial) stations in the Beaumont-Port Arthur, Texas Arbitron Market (Market #133). Cumulus controls four FM stations and two AM stations in the market. The number of stations indicated falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Beaumont-Port Arthur, Texas market.

5. Based on the compliance shown in both rated and non-rated markets, the transfer of control is in compliance with the Commission's multiple ownership rules, with regard to the stations referenced above.

6. The foregoing technical statement was prepared on behalf of Cumulus Media Inc. by Graham Brock, Inc., their Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.5 BIA database. Technical data related to AM and FM facilities was extracted from the Commission's CDBS database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.

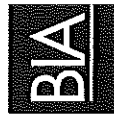





Cumulus also has an attributable interest in CMP Houston-KC, LLC, the licensee of KCMO, 710 kHz, Kansas City, Kansas; KCMO-FM, Channel 235C0, Shawnee, Missouri; KCJK, Channel 286C1, Garden City, Missouri; and KCFX, Channel 266C1, Harrisonville, Missouri.

- 1) KDVV has a permit to upgrade to Channel 262C at its existing site (BPH-20100921ACT). grade contour of the permit completely encompasses the licensed city grade contour, only the KDVV permit will be considered herein.
 - 2) KDVB has a construction permit to relocate and upgrade to Channel 245C2 (BPH-20080321ACL). Since the city grade contour of the permit completely encompasses the licensed city grade contour, only the KDVB permit will be considered herein.
 - 3) CMP Houston is currently the licensee of KMJK, Channel 297C1, North Kansas City, Missouri. CMP Houston is placing KMJK in a divestiture trust and, as such, will no longer have an attributable interest in that facility upon consummation of the proposed transaction.

2. KCMO, KCMO-FM, KCJK and KCFX are each licensed to a community in a metro county in the Kansas City, Kansas, Arbitron market. KCHZ is not a metro station in the Kansas City market, but is considered “home” to that market. KTOP-FM, KTOP, KDVV, KWIC, KMAJ-FM and KMAJ are each licensed to a community in a metro county in the Topeka, Kansas Arbitron Market. KDVB and the application for the new FM at Humboldt, Nebraska are not metro stations in nor considered home to any Arbitron rated market. Therefore, this review will verify compliance of commonly owned stations in both rated and non-rated markets.

KANSAS CITY, MISSOURI-KANSAS ARBITRON/BIA MARKET REVIEW

3. As shown on Exhibit #1, there are forty-four AM and FM (commercial and non-commercial) stations in the Kansas City, Missouri/Kansas Arbitron Market (Market #32). Cumulus would be in control of three FM stations and one AM station in the market. The number of stations depicted falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission’s rules. At this level, common ownership or control of up to seven stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Kansas City, Kansas/Missouri market.

TOPEKA, KANSAS ARBITRON/BIA MARKET REVIEW

4. As shown on Exhibit #2, there are fifteen AM and FM (commercial and non-commercial) stations in the Topeka, Kansas Arbitron Market (Market #198). Cumulus would be in control of four FM stations and two AM stations in the market. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission’s rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Therefore, Cumulus is in compliance in the rated Topeka, Kansas market.

REVISED CONTOUR OVERLAP ANALYSIS

5. Attached as Exhibit #3 is a map depicting the city grade contours of the commonly owned facilities. The proposed city grade contour of the application for a new FM at Humboldt, Nebraska, does not overlap with any of the other stations that are commonly owned. The city grade contours of KCHZ and the KDVB permit do, however, have contour overlap with several of the subject stations. Based on the area of overlap of these facilities, five distinct overlap markets are created. Market #1 consists of AM stations KMAJ and KTOP and FM stations KMAJ-FM, KTOP-FM, KWIC, KCHZ and KDVB (license and application). Market #2 consists of AM stations KMAJ and KTOP and FM stations KDVB permit, KMAJ-FM, KTOP-FM and KDVB (license and application). Market #3 consists of KMAJ and KTOP and FM stations KCHZ, KDVB permit, KTOP-FM and KDVB (license and application). Market #4 consists of AM stations KCMO and FM stations KCHZ and KDVB permit. Market #5 consists of AM station KCMO and FM stations KCHZ, KCFX, KCJK and KCMO-FM.

6. A study has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. In Markets #1, #2 and #3 the city grade contour of KCHZ and the KDVB application will be used to define the market boundary. In Markets #4 and #5 the city grade contour of KCHZ will be used to define the market boundaries. We will determine the number of contributing stations which have sites within, or provide city grade service to the Radio Market boundaries. To this total, we will then add the subject stations in the respective market to demonstrate compliance with the rules. Only those stations with transmitter sites within 92.0 kilometers will be considered as contributors to the market. No other station in which the Cumulus has an interest will be considered, unless it is a subject station in the market under review.

7. Exhibit #4 is a depiction of the stations (commercial and non-commercial) providing service to the Radio Market #1, #2 and #3 boundary. Thirty-nine stations are depicted. Exhibit #5 is a tabulation of the stations in Radio Market #1. A total of forty-six stations are shown, including the seven subject stations.⁴ The number of stations in the Radio Market falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. As such, Cumulus is in compliance in the non-rated Radio Market #1.

8. Exhibit #6 is a tabulation of the stations in Radio Market #2. A total of forty-five stations are shown, including the six subject stations.⁵ The number of stations in the Radio Market falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. As such, Cumulus is in compliance in the non-rated Radio Market #2.

9. Exhibit #7 is a tabulation of the stations in Radio Market #3. A total of forty-five stations are shown, including the six subject stations.⁶ The number of stations in the Radio Market falls in the forty-five or more stations tier of §73.3555(a)(1)(i) of the Commission's rules. At this level, common ownership or control of up to eight stations, with no more than five in the same service, is permissible. As such, Cumulus is in compliance in the non-rated Radio Market #1.

10. Exhibit #8 is a depiction of the stations (commercial and non-commercial) providing service to the Radio Market #4 and #5 boundaries. Sixteen stations are depicted. Exhibit #9 is a tabulation of the stations in Radio Market #4. A total of nineteen stations are shown, including the three subject stations.⁷ The number of stations in the Radio Market falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. As such, Cumulus is in compliance in the non-rated Radio Market #4.

11. Exhibit #10 is a tabulation of the stations in Radio Market #5. A total of twenty-one stations are shown, including the five subject stations.⁸ The number of stations in Radio Market #3 falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules. At this level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. As such, Cumulus is in compliance in the non-rated Radio Market #5.

12. Based on the compliance shown in both rated and non-rated markets, the proposed transfer is in compliance with §73.3555 of the rules, with regard to the above referenced stations.
