Dear Licensee:

Entercom New Orleans License, LLC ("Entercom") is hereby notified of the modification of its license for WKBU(FM), New Orleans, LA, to specify operation on Channel 239C0.

On July 5, 2012, Blakeney Communications, Inc. ("Blakeney"), licensee of station WBBN(FM), Taylorsville, MS, filed a minor change application. Blakeney's application proposed that WKBU's license and assignment be modified to specify Class C0 in lieu of Class C in accordance with the procedures set forth in Note 4 of 47 C.F.R. § 73.3573.² Accordingly, by staff letter dated August 9, 2012, WKBU was given thirty days notice to show cause why its license should not be modified to specify Channel 239C0 in lieu of Channel 239C. Subsequently, by letter received February 28, 2013, WKBU stated its intention to accept Class C0 status concurrent with the grant of the WBBN permit application.

Accordingly, pursuant to the authority found in Sections 4(i), 5(c)(1), 303, and 307(b) of the Communications Act of 1934, as amended, and Sections 0.61, 0.204(b), 0.283, 1.420, 73.203(b), and 73.3573 of the Commission's Rules, as amended, IT IS ORDERED, that effective the date of this letter, the FM assignment IS MODIFIED, as follows:
