**Changes in Ownership Structure**

\_\_\_\_\_ As set forth in this application, WTVQ-TV, Inc., is a for-profit corporation. The sole stockholder of WTVQ-TV, Inc. is Morris Network, Inc., which in turn is 100 percent owned by Morris Multimedia, Inc. The instant application proposes to keep this ownership structure in place but to assign the licenses and assets of WTVQ-TV to a subsidiary, WTVQ-TV, LLC, owned 97.5 percent by WTVQ-TV, Inc. and 2.5 percent by H. Dean Hinson. The ownership, officers, and directors of each company are more fully set forth below. It should be noted that there are no new parties acquiring any interest in the licensee, as Mr. Hinson has previously held an attributable interest as the President of WTVQ-TV, Inc. and its parent company, Morris Network, Inc. All persons listed below are citizens of the United States of America.
