Lewis W. Dickey, Jr., David W. Dickey, John W. Dickey, and Michael W. Dickey (collectively, the Dickey Brothers) each holds a 24% interest in DBBC, L.L.C. (DBBC). DBBC wholly owns Phoenix Communications Group, Inc., which in turn holds all of the outstanding stock of Phoenix of Hendersonville, Inc., holder of the license for WQQK(FM) (Facility ID #52521), Hendersonville, Tennessee. DBBC also wholly owns Mt. Juliet Broadcasting, Inc. which holds the license for WNPL(FM) (Facility ID #29862), Belle Meade, Tennessee. In addition, DBBC is the licensee of WRQQ(FM) (Facility ID #26689), Goodlettsville, Tennessee.

Lewis W. Dickey, Sr., father of the Dickey Brothers, holds 99.1% of the stock of Dickey Broadcasting Company (DBC), the licensee of WALR(AM) (Facility ID #1098), Atlanta, Georgia, WFOM(AM) (Facility ID #72066), Marietta, Georgia, and WCNN(AM) (Facility ID #56389), North Atlanta, Georgia. Lewis W. Dickey, Sr., Patricia A. Dickey, mother of the Dickey Brothers, and David W. Dickey are officers of DBC.

Riverside Broadcasting, Inc. ("Riverside") holds the Commission authorization for commercial radio station WIMX(FM), Gibsonburg, Ohio. Cumulus Broadcasting, Inc. ("CBI") has supplied financing to Riverside in an amount which it believes exceeds 33% of Riverside's total capitalization calculated under the Commission's equity/debt plus ("EDP") standard. Cumulus Licensing Corp. ("CLC") holds Commission authorizations for other radio stations in the same market as

WIMX(FM), and the EDP attribution standard therefore may be triggered with respect to CBI's holding of debt of Riverside. CBI intends to assign its rights as creditor of Riverside to an independent third party and is currently taking steps to implement this plan. CLC and CBI will complete these steps as expeditiously as practicable. In the interim, and to the extent such a waiver is necessary, CLC respectfully requests a temporary waiver of the application of the EDP standard with respect to CLC and station WIMX until CLC and CBI can implement the proposed solution with respect to this station. The requested waiver would (1) apply only to the existing debt interests in the licensee of this station, (2) extend only for the limited period of time beyond the one-year period allowed by the Commission for compliance with the EDP standard that is necessary to enable CLC and CBI to complete the implementation of the above-described steps, and (3) would not disserve the public interest.
