

**ENGINEERING STATEMENT
RADIO FREQUENCY EXPOSURE

INTRODUCTION

This statement is made on behalf of Emmis Radio License, LLC., (Emmis), licensee of FM Radio Station KKFR(FM) at Glendale, Arizona. It presents a reply to the special operating condition on the KKFR(FM) Construction permit, FCC File BPH-20030926AQF relating to warning signs and site access.

The FCC Special operating condition No.2 states, "Warning signs which describe the radiofrequency electromagnetic fields hazard must be posted at appropriate intervals. Access must be restricted to prevent the exposure of humans to RF emissions in excess of the FCC guidelines (OET Bulletin 65, Edition 97-01, released August 1997). Permittee shall submit documentation of compliance with this special operating condition when filing FCC Form 302, application for license."

KKFR(FM) ACCESS AND SIGNS

Attached are several photographs taken by Clayton M. Creekmore, Director of Engineering, Emmis Phoenix KKFR(FM). The various photos clearly show the signage at transmitter towers and on the two access gates to the South Mountain site. The photos also show the fencing and automatic gates at the access roads to the site.

The photographs and this statement satisfy the FCC required special operating condition for documenting the signs and access control.






