BYLAWS OF ACTIVIST SAN DIEGO
A California Nonprofit Public Benefit Corporation

ARTICLE I
NAME AND LOCATION

- 1.1 Name. The name of this corporation is ACTIVIST SAN DIEGO.
- 1.2 Principal Office. The principal office for the transaction of the activities and affairs of this corporation is located at 4246 Wightman Street, San Diego, California 92105.
- 1.3 Change of Address. The Board of Directors is hereby granted full power and authority to change the principal office of the Corporation from one location to another in California. Any such change of location shall be noted by the Secretary on these Bylaws opposite this Section; alternatively, this Section may be amended to state the new location.

ARTICLE II
PURPOSES

- 2.1 General Purpose. The purpose of this corporation is to empower communities and increase civic involvement by educating individuals and organizations about social issues, networking for progressive social change, providing resources to the community, showcasing accomplishments, and linking activists and activist organizations.
 - 2.1.1 The purpose of this corporation is also to apply for, license and operate one or more noncommercial, educational broadcast stations, and to serve and fully qualify as a "public telecommunications entity" within the intent of 47 U.S.C. Section 397(12).
- 2.2 Specific Purposes. Activist San Diego was formed in 1999 in response to the need for an efficient, effective, and coordinated way for activists to respond to social problems in the community. Member organizations and individuals work for systemic social change in the pursuit of a just, equitable, and sustainable society.
 - 2.2.1 Activist San Diego shall provide programming, media access and educational programs and services, including but not limited to programs of educational merit including those concerned with scientific, cultural, historical, and humane studies; adult education, distance learning, programs in support of K-12 and higher education; programs incident to for-credit instruction and general interest programs.
 - 2.2.2 This Corporation will support and strengthen the technological, organizational, and outreach infrastructures of local non-profits and fledgling organizations that represent marginalized groups in the

community through a web site that disseminates information to the public and provides web space for social justice organizations, and through community organizing, training and educational activities.

- 2.2.3 Activist San Diego will work on behalf of its members to acquire needed skills, equipment and other resources in order to increase the networking abilities of progressive organizations, provide a voice for those traditionally kept silent and challenge the institutional structures that contribute to systematic oppression and injustice.
- 2.2.4 A guiding principle of Activist San Diego is that it is critical to showcase the valor, passions, good works and social aspects of the movement to others not currently active. It is equally important for long-time activists to see that the good results of their work is recognized, so as to sustain their enthusiasm.

ARTICLE III **DEDICATION OF ASSETS**

3.1 Dedication of Assets. This Corporation's assets are irrevocably dedicated to public and charitable purposes. No part of the net earnings, properties, or assets of the Corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or to any director, officer, or member of the Corporation. On liquidation and dissolution, all properties and assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to such organization (or organizations) organized and operated exclusively for charitable purposes, and that has established its tax-exempt status under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provisions of any future federal internal revenue law).

ARTICLE IV **MEMBERS**

- 4.1 Classes and Qualifications. This Corporation shall have two (2) classes of members, designated as organizational and individual. Any person dedicated to the purposes of the Corporation shall be eligible for membership on approval of the membership application by the Board and on timely payment of such dues and fees as the Board may fix from time to time.
- 4.2 Voting Rights. All members shall have the right to vote, as set forth in these bylaws, on the election of directors, on the disposition of all or substantially all of the corporation's assets, on any merger and its principal terms and any amendment of those terms, and on any election to dissolve the corporation. In addition, those members shall have all rights afforded members under the California Nonprofit Public Benefit Corporation Law.
- 4.3 Members' Dues, Fees and Assessments. Each member must pay, within the time and on the conditions set by the Board, the dues, fees, and assessments in amounts to be fixed from time to time by the Board. The dues, fees, and assessments shall

5.5.1 Directors must excuse themselves from voting and may not vote on any issue where they have any financial interest.

5.5.2 at all times shall maintain "local diversity of ownership" as that is defined in FCC Rules and Regulations, Section 73.7003(b)(2), 47 C.F.R. Section 73.7003(b)(2). At no time shall the Corporation, any parent or subsidiary entity, any voting member, or any officer or director of the Corporation, have an attributable interest in another radio station, including any license, construction permit or debt or equity position, if the principal community contour of such station would overlap in any part with the principal community contour of a new noncommercial radio station for which the Corporation files an FCC application for construction permit.

5.6 Election of Directors. The following number of directors shall be elected at each annual members' meeting, to hold office for a period of three (3) years:

- 5.6.1 If seven (7) directors serve on the Board, two (2) shall be elected in that year.
- 5.6.2 If eight (8) directors serve on the Board, three (3) shall be elected in that year.
- 5.6.3 If nine (9) directors serve on the Board, three (3) shall be elected in that year.
- 5.6.4 If ten (10) directors serve on the Board, three (3) shall be elected in that year.
- 5.6.5 If eleven (11) directors serve on the Board, four (4) shall be elected in that year.
- 5.6.6 If twelve (12) directors serve on the Board, four (4) shall be elected in that year.
- 5.6.7 If thirteen (13) directors serve on the Board, four (4) shall be elected in that year.
- 5.6.8 If fourteen (14) directors serve on the Board, five (5) shall be elected in that year.
- 5.6.9 If fifteen (15) directors serve on the Board, five (5) shall be elected in that year.

If directors are not elected at any annual meeting, they may be elected at any special member's meeting held for that purpose or by written ballot.

5.7 Terms of Office. Each Director shall serve staggered three (3) year terms. Each director, including a director elected to fill a vacancy or elected at a special members' meeting or by written ballot, shall hold office until expiration of the term for which elected and until a successor director has been designated and qualified.

5.8 Nomination of Directors.

- 5.8.1 Nominations by Committee. The President shall appoint a committee to nominate qualified candidates for election to the Board at least sixty (60) days before the date of any election of directors. The nominating committee shall make its report at least thirty (30) days before the date of the election, or at such other time as the board may set, and the Secretary

6.6.3 Secretary. The secretary shall keep or cause to be kept, at the corporation's principal office or such other place as the board may direct, a book of minutes of all meetings, proceedings, and actions of the board, of committees of the board, and of members' meetings. The minutes of meetings shall include the time and place that the meeting was held; whether the meeting was annual, general, or special, and, if special, how authorized; the notice given; the names of persons present at board and committee meetings; and the number of members present or represented at members' meetings.

The secretary shall keep or cause to be kept, at the principal California office, a copy of the articles of incorporation and bylaws, as amended to date.

The secretary shall keep or cause to be kept, at the corporation's principal office or at a place determined by resolution of the board, a record of the corporation's members, showing each member's name, address, and class of membership.

The secretary shall give, or cause to be given, notice of all meetings of members, of the board, and of committees of the board that these bylaws require to be given. The secretary shall keep the corporate seal, if any, in safe custody and shall have such other powers and perform such other duties as the board or the bylaws may require.

6.6.4 Treasurer. The Treasurer shall keep and maintain, or cause to be kept and maintained, adequate and correct books and accounts of the corporation's properties and transactions. The Treasurer shall send or cause to be given to the members and directors such financial statements and reports as are required to be given by law, by these bylaws, or by the board. The books of account shall be open to inspection by any director at all reasonable times.

The Treasurer shall (i) deposit, or cause to be deposited, all money and other valuables in the name and to the credit of the corporation with such depositories as the board may designate; (ii) disburse the corporation's funds as the board may order; (iii) render to the President and the Board, when requested, an account of all transactions as Treasurer and of the financial condition of the corporation; and (iv) have such other powers and perform such other duties as the board or the bylaws may require.

ARTICLE VII MEETINGS AND QUORUMS

7.1 Meetings of the Board of Directors.

7.1.1 Location. Meetings of the Board shall be held at any place within the State of California that has been designated by resolution of the Board or in the notice of the meeting.

7.1.1.2 The Corporation shall maintain a permanent headquarters within 25 miles of the main post office of Ramona, CA.

7.1.2 Board Meetings. Regular meetings of the Board of Directors shall be held at least every three (3) months, or more often, at such time and at such place as may be determined by the President. Notice of regular meetings

Nature, Educational Purpose and Educational Programs of Activist San Diego

The purpose of this exhibit is to set forth how the Activist San Diego's FM radio station will be used to advance informational and educational programming, as required by Form 340, Section II, Question 4B.

Activist San Diego intends to provide programming not currently available in the local community, including programming that responds to the ascertained problems, needs, and interests of the community of license and the surrounding service area. In addition to daily local news, talk, media analysis, and public service programming, we intend to focus specialized local programming on local arts, local history, public policy, burning political issues, the San Diego /border economy, environment, health/medical/health care information (including the special needs of senior citizens and children), youth/student, parenting, governmental affairs (state, county, and local), K-12 education for parents & students, Spanish language programming and the local cultural scene.

Activist San Diego will also produce programming featuring local lectures, concerts, poetry and literary readings, theater productions and other artistic talents.
