

Figure 13.0 is an allocation study showing the interfering contours for the proposed facilities in relation to the protected contours for all FM broadcast, FM translator, and Low Power FM stations which require protection consideration. As can be seen from this figure, no overlap will occur between the protected contour for each of these stations and the respective interfering contour for the proposed facilities. Based upon this information, the proposed facilities will provide the required protection to all stations requiring consideration.

Table 13.0 is an FM spacing study which demonstrates that the proposed facilities will comply with the intermediate frequency separation requirements outlined in Section 73.207 of the FCC Rules with regard to all existing or proposed stations operating on FM Channels 293 and 294.


