

## COMPREHENSIVE EXHIBIT

### I. Introduction

The instant application is one of a number of concurrently filed Form 315 applications (the “Applications”) that seek the Commission’s consent to the involuntary transfer of control (the “Transfer of Control”) of 17 Commission licensees (the “Licensees”) under the control of ViacomCBS Inc. (“ViacomCBS”).<sup>1</sup> As explained below, the involuntary Transfer of Control of the Licensees results from the death on August 11, 2020 of Mr. Sumner M. Redstone (“Mr. Redstone”). Collectively, the Licensees hold Commission licenses for 29 television broadcast stations. A list of the Licensees, and the specific licenses held by each of them, is attached to this Comprehensive Exhibit as **Attachment A**.

ViacomCBS is controlled by National Amusements, Inc. (“NAI”), its single majority shareholder, which holds approximately 79% of the voting stock of ViacomCBS.<sup>2</sup> Until the death of Mr. Redstone, NAI was controlled by Mr. Redstone, who had sole control over the 80% voting stock and equity of NAI held by the Sumner M. Redstone National Amusements Trust u/d/t dated June 28, 2002 (the “SMR Trust”).<sup>3</sup> In addition to Mr. Redstone, the other trustees of the SMR Trust were David R. Andelman, Norman I. Jacobs, Thaddeus P. Jankowski, Jill S. Krutick, Leonard L. Lewin, and Phyllis Redstone. Because ViacomCBS is controlled by a single majority shareholder, NAI, and NAI was controlled by Mr. Redstone through the SMR Trust, Mr. Redstone controlled ViacomCBS and the Licensees until his death.

Upon Mr. Redstone’s death, the voting stock and equity of NAI held by the SMR Trust was automatically and involuntarily divided equally between two continuing trusts created under the same trust agreement that created the SMR Trust: the Sumner M. Redstone National Amusements Life Income Trust (the “SMR Life Income Trust”) and the Sumner M. Redstone National Amusements Part B General Trust (the “SMR Part B Trust”) and collectively with the SMR Life Income Trust, the “Continuing Trusts”). As a result, each of the Continuing Trusts holds 40% of the voting stock and 40% of the equity of NAI. The Continuing Trusts are required to share seven common voting trustees, who currently are: Shari E. Redstone, Tyler J. Korff, David R. Andelman, Norman I. Jacobs, Thaddeus P. Jankowski, Jill S. Krutick and Leonard L. Lewin (collectively, the “Trustees”).<sup>4</sup> Organizational charts showing control of the relevant entities prior to and following Mr. Redstone’s death are attached to this Comprehensive Exhibit as **Attachment B**.

Therefore, in lieu of filing *pro forma* applications on Form 316, which generally contemplate such an interim arrangement, ViacomCBS is filing concurrent Form 315 applications seeking approval of the transfer of control of the Licensees to the Continuing Trusts as described herein.

Pursuant to the document creating and governing the SMR Trust and the Continuing Trusts, each of the Trustees has an equal vote, and decisions with respect to the NAI stock are made by majority vote of the Trustees, except for decisions pertaining to any sale, merger, reorganization or similar business transaction, including the disposition of NAI's interests in ViacomCBS. Such decisions require approval by a majority of disinterested Trustees (*i.e.*, Mr. Andelman, Mr. Jacobs, Mr. Jankowski, Ms. Krutick and Mr. Lewin) and by a majority of all Trustees. The Trustees are required to cause each of the two Continuing Trusts to vote the NAI shares held by such Continuing Trust in the same manner as the shares held by the other Continuing Trust. Consequently, upon Mr. Redstone's death, the Continuing Trusts automatically and involuntarily succeeded Mr. Redstone (through the SMR Trust) as the controlling entities of NAI and therefore the indirect controlling entities of the Licensees. The Applications request Commission consent to the involuntary Transfer of Control of the Licensees to the Continuing Trusts.

The Licensees in the aggregate hold Commission licenses for 28 full power television broadcast stations (including one satellite station, KCCW, Walker MN, FIN 9640) and one Class A television station (WBXI-CD, Indianapolis, IN, FIN 70416), located in 17 Designated Market Areas ("DMAs"). In ten of those DMAs, one or more Licensees hold the licenses for two full power non-satellite television stations.<sup>5</sup> In each of those ten DMAs, the TV duopolies are in compliance with the 8 independently owned and operated full power station standard, and one of the two commonly-controlled stations is not ranked among the top four stations based on audience share, as required by the Commission's local television multiple ownership rule.<sup>6</sup> The Transfer of Control will not result in any new combinations of media ownership. The Licensees respectfully request the prompt grant of this and the associated applications.<sup>7</sup>

<sup>7</sup> The applicants are contemporaneously filing separate applications with the Wireless Telecommunications and International Bureaus seeking Commission consent to the related transfer of control of microwave, land mobile and earth station authorizations held by the Licensees and/or other subsidiaries of ViacomCBS. The parties intend that the applications filed in connection with the Transfer of Control include all of the licenses and other FCC authorizations held by ViacomCBS and all of its direct and indirect subsidiaries. Such companies may now have on file, and may hereafter file, additional requests for authorizations for new or modified facilities that may be granted before the Commission takes action on the transfer applications. Accordingly, the applicants request that any Commission approval of the applications relating to the Transfer of Control include authority for the Continuing Trusts to acquire control of: (1) any authorization issued to ViacomCBS or its subsidiaries relating to its broadcast businesses while the Transfer of Control is pending before the Commission and during the period required for consummation of the Transfer of Control; and (2) any applications filed by ViacomCBS or its subsidiaries relating to its broadcast businesses that are pending at the time of consummation. Such action would be consistent with prior decisions of the Commission. *See, e.g., Applications of AT&T Inc. and Celco Partnership d/b/a Verizon Wireless*, Memorandum Opinion and Order, 25 FCC Rcd 8704, 8773, ¶ 165 (2010); *SBC Communications Inc. and AT&T Corp. Applications for Approval of Transfer of Control*, Memorandum Opinion and Order, 20 FCC Rcd 18290, 18392, ¶ 212 (2005); *Applications of AT&T Wireless Services, Inc. and Cingular Wireless Corp. for Consent to Transfer Control of Licenses and Authorizations*, Memorandum Opinion and Order, 19 FCC Rcd 21522, 21626 ¶ 275 (2004). The parties also request that Commission approval include any authorizations that may have been inadvertently omitted. Similarly, pursuant to Sections 1.927(h), 1.929(a)(2), and 1.933(b) of the Commission's Rules, to the extent necessary, the applicants request a blanket exemption from any applicable cut-off rules in cases where the licensees in this Transfer of Control file amendments to pending applications in order to reflect consummation of the proposed Transfer of Control so that such amendments are not treated as disqualifying amendments. The nature of the proposed Transfer of Control demonstrates that the ownership changes are not being

## **II. Transaction Agreements**

As described above, as a result of the death of Mr. Redstone, the Continuing Trusts automatically and involuntarily succeeded Mr. Redstone (through the SMR Trust) as controller of NAI. Consequently, there are no contracts or agreements specifically relating to the Transfer of Control. A summary of the relevant terms of the governing document for the Continuing Trusts follows:

### **SMR Part B Trust**

(A) Name of trust: Sumner M. Redstone National Amusements Part B General Trust.

(B) Duration of trust: Until the death of the last of Shari Redstone, Brent Redstone, or Phyllis Redstone.

(C) Number of shares of voting stock owned: 33 1/3, representing 40 percent of total voting interest in NAI.

(D) Names of beneficiaries of trust: Phyllis Redstone and the descendants of Sumner M. Redstone. Distributions from the trust are at the sole discretion of the Trustees.

(E) Name of record owner of stock: Sumner M. Redstone National Amusements Part B General Trust.

(F) Name of the party or parties who have the power to vote or control the vote of the shares: Shari E. Redstone, Tyler J. Korff, David R. Andelman, Norman I. Jacobs, Thaddeus P. Jankowski, Jill S. Krutick and Leonard L. Lewin, as Trustees.

(G) Any conditions on the powers of voting the stock or any unusual characteristics of the trust: Each of the Trustees has an equal vote, and decisions with respect to the NAI stock are made by majority vote of the Trustees, except for decisions pertaining to any sale, merger, reorganization or similar business transaction, including the disposition of interests in ViacomCBS. Such decisions require approval by a majority of disinterested Trustees (*i.e.*, Mr. Andelman, Mr. Jacobs, Mr. Jankowski, Ms. Krutick, and Mr. Lewin) and by a majority of all Trustees.

made for the purpose of acquiring any particular pending application, but are the result of the death of Mr. Redstone, who, at the time of his death, was the controlling person of ViacomCBS. Grant of this request would be consistent with prior Commission decisions that routinely have granted a blanket exemption in cases involving multiple-license transactions. *See, e.g., Applications of PacifiCorp Holdings, Inc., and Century Telephone Enterprises, Inc. for Consent to Transfer Control of Pacific Telecom, Inc., a Subsidiary of PacifiCorp Holdings, Inc.*, Memorandum Opinion and Order, 13 FCC Rcd 8891, 8915 ¶ 47 (1997); *Applications of NYNEX Corp. and Bell Atlantic Corp.*, Memorandum Opinion and Order, 12 FCC Rcd 19985, 20091, 20092 ¶ 234 (1997).

### SMR Life Income Trust

(A) Name of trust: Sumner M. Redstone National Amusements Life Income Trust.

(B) Duration of trust: Until the death of Phyllis Redstone.

(C) Number of shares of voting stock owned: 33 1/3, representing 40 percent of total voting interest in NAI.

(D) Name of beneficiary of trust: Phyllis Redstone.

(E) Name of record owner of stock: Sumner M. Redstone National Amusements Life Income Trust.

(F) Name of the party or parties who have the power to vote or control the vote of the shares: Shari E. Redstone, Tyler J. Korff, David R. Andelman, Norman I. Jacobs, Thaddeus P. Jankowski, Jill S. Krutick and Leonard L. Lewin, as Trustees.

(G) Any conditions on the powers of voting the stock or any unusual characteristics of the trust: Each of the Trustees has an equal vote, and decisions with respect to the NAI stock are made by majority vote of the Trustees, except for decisions pertaining to any sale, merger, reorganization or similar business transaction, including the disposition of interests in ViacomCBS. Such decisions require approval by a majority of disinterested Trustees (*i.e.*, Mr. Andelman, Mr. Jacobs, Mr. Jankowski, Ms. Krutick and Mr. Lewin) and by a majority of all Trustees.

### **III. Other Authorizations**

**Attachment A** to this Comprehensive Exhibit sets forth the call signs, locations, and facility identifiers of all broadcast stations in which the transferees, the Licensees, and/or any other parties to the Applications have an attributable interest.

### **IV. Parties to the Applications and Changes in Interests as Result of Transfer**

The ownership structure of ViacomCBS and the Licensees will not change following the Transfer of Control, except that NAI will be controlled by the Continuing Trusts. **Attachment B** shows the ownership of ViacomCBS and the Licensees both before and after completion of the Transfer of Control.

The tables set forth in **Attachment C**, which are consistent with the format of Section IV, Question 6.a on Form 315, list the following for (i) the Trustees, (ii) the trustees of the Shari Ellin Redstone Trust, and (iii) the Officers and Directors of NAI, ViacomCBS, the Licensees, and the subsidiaries of ViacomCBS that hold attributable interests in the Licensees:

- (1) Name and address of the transferee and each party to the application holding an attributable interest
- (2) Citizenship

- (3) Positional interest
- (4) Percentage of votes
- (5) Percentage of total assets (equity plus debt)

## **V. Pending Renewal Applications**

ViacomCBS has a pending application for renewal of its broadcast license for station WJZ-TV, Baltimore, MD, and may file additional applications for renewal of broadcast authorizations prior to Commission approval of the Transfer of Control. With respect to any of these applications for which ViacomCBS is unable to complete the renewal process prior to grant of the Applications and approval of the Transfer of Control, the applicants request that the Commission apply its policy permitting processing of multi-station long-form applications that involve stations with pending license renewal applications where (1) no basic qualifications issues have been raised or, if raised, were resolved favorably, and (2) the purchaser explicitly assents to standing in the stead of the seller in any renewal proceeding that is pending at the time of consummation of the transaction. Post-Transfer of Control ViacomCBS and its subsidiaries agree to succeed to the position of pre-Transfer of Control ViacomCBS and its subsidiaries in any pending license renewal applications and to assume the consequences thereof, consistent with the procedures set forth in *Shareholders of CBS Corporation*, 16 FCC Rcd 16072, ¶ 3 (2001) (“The Commission repeatedly has held that, in multi-station transactions, it will grant the transfer of control application while the renewal application is pending as long as there are no basic qualification issues pending against the transferor or transferee that could not be resolved in the context of the transfer proceeding, and the transferee explicitly assents to standing in the stead of the transferor in the pending renewal proceeding.”). No basic qualification issues have been raised in connection with pending application for renewal of broadcast license for station WJZ-TV.

## **VI. Request for Satellite Station Waiver**

One of the Licensees, CBS Broadcasting, Inc., holds the Commission licenses for stations WCCO-TV, Minneapolis, MN, FIN 9629, and KCCW-TV, Walker, MN, FIN 9640. KCCW-TV is a satellite station of WCCO-TV and operates as such pursuant to a satellite station waiver of the Commission’s local television multiple ownership rule.<sup>8</sup> The Continuing Trusts hereby certify that the underlying circumstances upon which the Commission relied in granting the current satellite authorization have not changed materially since the issuance of the most recent satellite authorization. The Commission granted the current satellite waiver in *Shareholders of CBS Corporation (KCBS-TV)*, 15 FCC Rcd. 8230 (2000).

## **VII. Compliance with National Audience Cap**

Commission rules prohibit the grant, transfer or assignment of a license for a commercial television broadcast station to a party (or parties under common control) if such grant, transfer or assignment would result in such party or certain affiliates having a cognizable interest in

television stations which have an aggregate national audience reach exceeding 39 percent.<sup>9</sup> Both before and after the Transfer of Control, the national audience reach of the television stations in which ViacomCBS or any other party to the Application has an attributable interest, as calculated pursuant to section 73.3555(e) of the Commission's rules, is and will be less than 39%. Materials detailing such calculation are attached as **Attachment D** to this Comprehensive Exhibit.

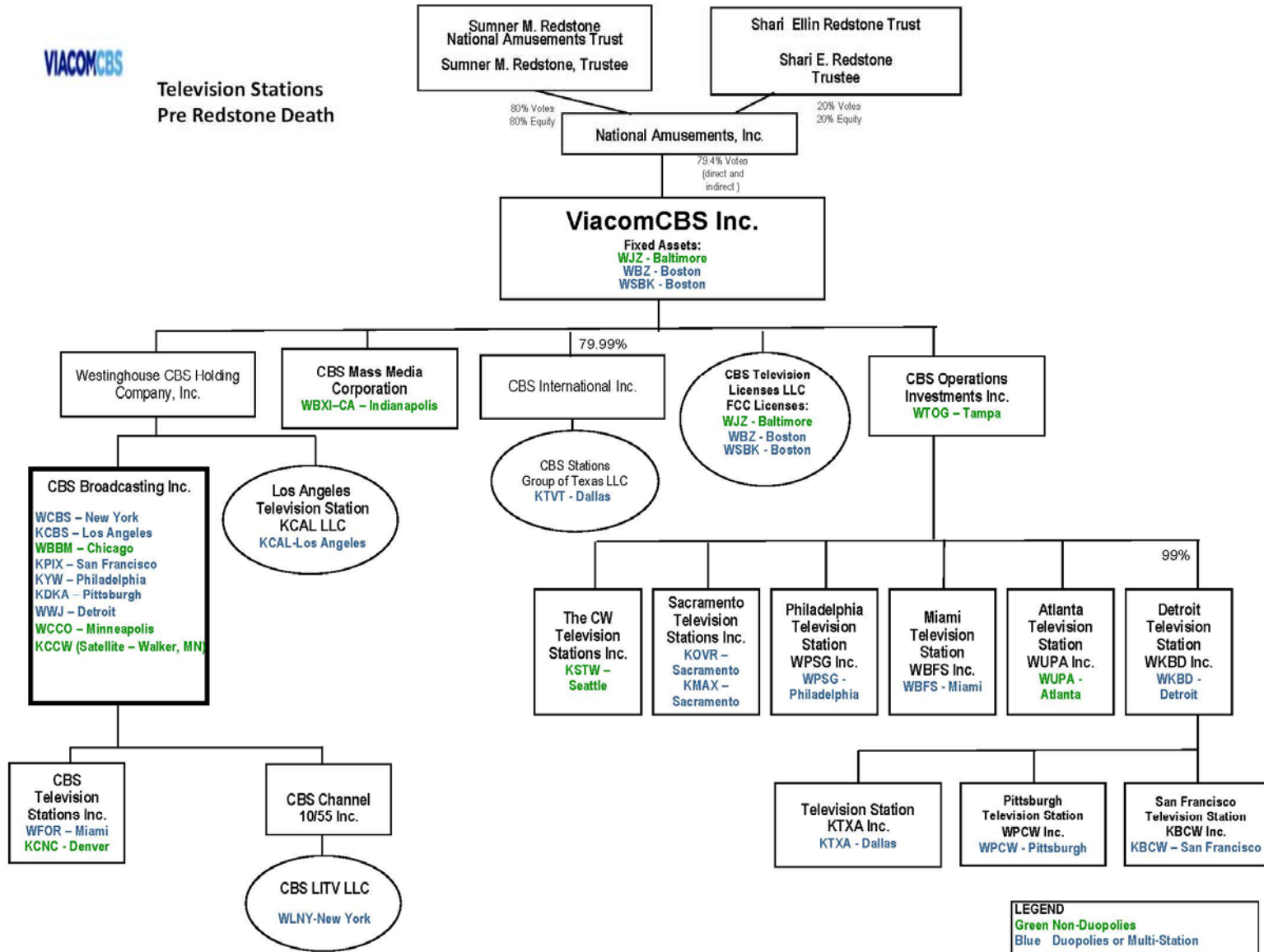

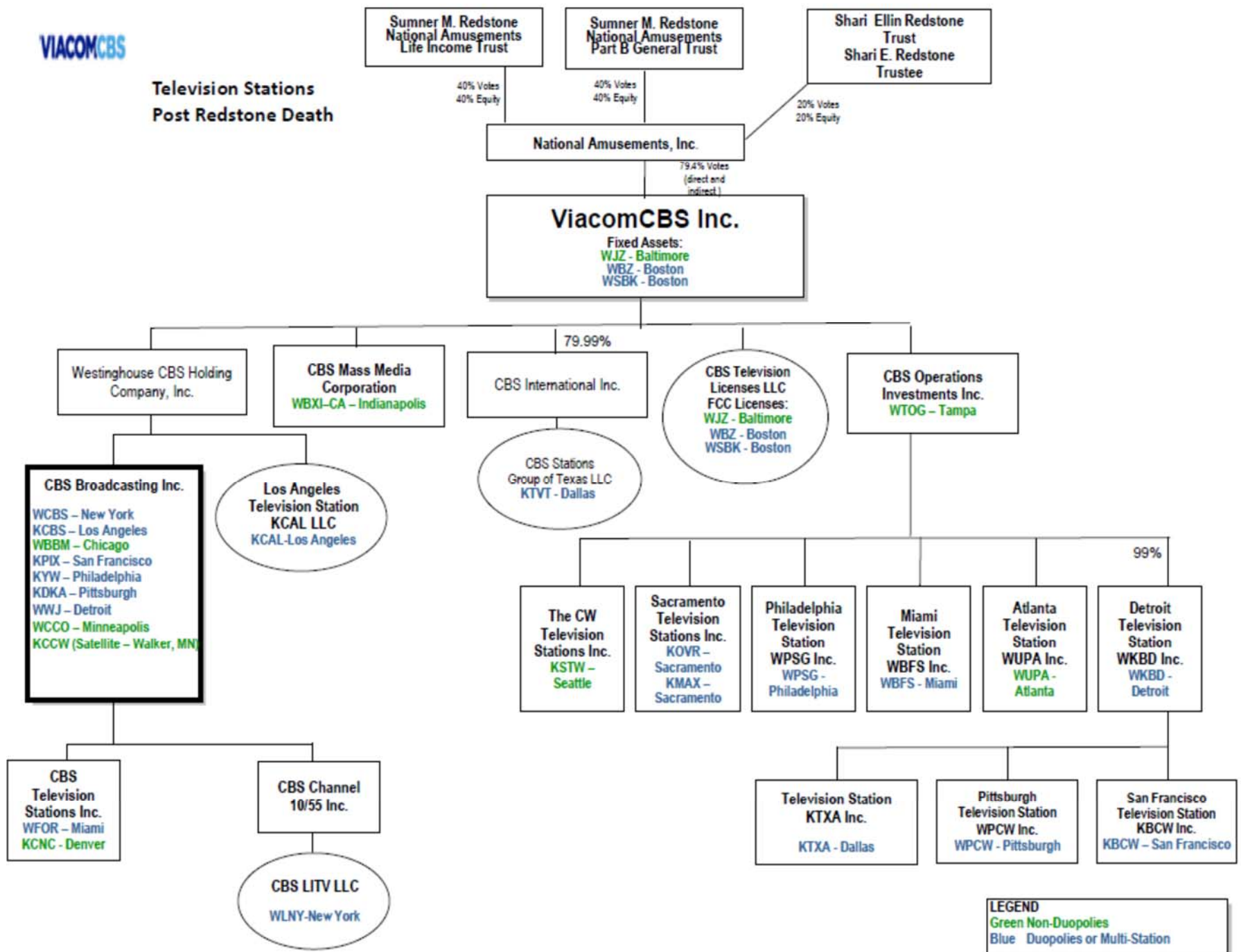


## Television Stations Pre Redstone Death
