**(Section III, Question 5)**

**I. INTRODUCTION**

This application seeks Commission approval for the transfer of control of Telemundo of Puerto Rico, a Puerto Rico general partnership and the licensee of Station WKAQ-TV, San Juan, Puerto Rico, and associated television translator stations, from Telemundo Group, Inc. (transferor) to NBC/Telemundo License Co. ("LicenseCo") (transferee). The licensee, transferor, and proposed transferee are all indirect, wholly owned subsidiaries of General Electric Company ("GE"). Therefore, *pro forma* treatment is appropriate for the proposed transfer of control.

As discussed below, the proposed transfer of control is part of a larger reorganization of all of the 20-plus GE subsidiaries (the "GE FCC Subsidiaries") that control Part 73 or Part 74 Commission authorizations ("FCC Authorizations"),<sup>1</sup> which the Commission has approved but which has not yet been consummated. That prior Commission approval includes consent to the *pro forma* assignment of the license of WKAQ-TV from Telemundo of Puerto Rico to LicenseCo. See FCC File No. BALCT-20031106AJO. For business reasons, however, GE has tentatively concluded that it would be better to retain parts of the current ownership structure of Station WKAQ-TV rather than assign the WKAQ-TV license out of the current licensee. GE anticipates consummating the proposed reorganization, including the transfer of control proposed herein, within the next 45 days. To ensure that GE holds all necessary authorizations to complete the reorganization, it seeks to maintain the current status of the outstanding consent to assignment of WKAQ-TV's license, while prosecuting the instant application to a final grant.

Upon the earlier of (i) the approval of the proposed transfer of control becoming final or (ii) the consummation of the transfer of control proposed herein, GE will promptly relinquish consent to the previously approved assignment and dismiss the underlying assignment application in FCC File No. BALCT-20031106AJO. Accordingly, to the extent that such a procedure would arguably be inconsistent with the contingent application rule (Section 73.3517) or the rule against inconsistent or conflicting applications (Section 73.3518), GE respectfully requests a waiver of such rules. Because the instant application is *pro forma* in nature and Commission staff have previously passed upon and approved all of the entities in the proposed ownership structure, the concerns that led to the adoption of those rules regarding unwarranted burden on the Commission's staff and resources are not implicated by this application.

## **II. DETAILED DESCRIPTION OF TRANSACTION AND PARTIES**

Pursuant to *pro forma* applications filed on November 6, 2003, GE proposed to assign, through a series of contemporaneous steps, all of the licenses held by the GE FCC Subsidiaries (with the exception of Station Venture Operations, LP) to a single entity, LicenseCo. The licenses held by Station Venture Operations, LP were not proposed to be assigned to LicenseCo.; rather, for business reasons, GE proposed to transfer control of Station Venture Operations, LP from Outlet Broadcasting, Inc. ("Outlet") to LicenseCo. The Commission approved all of the proposed *pro forma* assignments and transfer of control on November 20, 2003. *See, e.g.*, BALCT-20031106AKM (pro forma assignment application for Station WNBC, New York, NY); Public Notice, Report No. 45619 (rel. Nov. 25, 2003). *Compare* Attachment B (demonstrating current NBC and Telemundo station ownership) *with* Attachment C (originally proposed NBC and Telemundo station ownership). Following consummation of the transfer of control proposed

herein, the ownership structure of the NBC and Telemundo stations will be as set forth in Attachment D. The only change in the reorganized structure will be the one proposed herein, pursuant to which LicenseCo will own WKAQ Holdings, Inc. and Telemundo of Puerto Rico. *Compare Attachment C with Attachment D.*

Following the proposed transaction, LicenseCo will be wholly owned by NBC Telemundo, Inc. (“NTI”). In turn, NBC Telemundo Holding Co. (“HoldCo”), a wholly owned, direct subsidiary of GE, will be NTI’s single majority voting shareholder, owning 55.6% of NTI’s votes and 20% of NTI’s equity. *See Attachment D.* Because GE shall control, at all times, all entities and assets necessary to the operations of the FCC Authorizations, the proposed transaction is *pro forma*.

The other parties to the application do not have *de facto* or *de jure* control over LicenseCo. The remaining 44.4% of NTI’s votes (and 80% of NTI’s equity) will be controlled by Outlet, which in turn is wholly owned by Outlet Communications, Inc. (“OCI”). National Broadcasting Company, Inc. (“NBC”) is the sole stockholder of OCI.<sup>2</sup> (Alternatively, depending on certain business or transactional considerations, Outlet and/or OCI may be replaced by one or more other direct or indirect subsidiaries of NBC.) NBC in turn is controlled by NBC Holdings, Inc. (“NBCHI”), which is wholly owned by GE.

The intended officers and directors of LicenseCo, NTI and HoldCo will include certain of the following, each of whom is a current officer or director of National Broadcasting Company, Inc. and/or Telemundo Communications Group, Inc. None of these persons will have an

attributable interest in LicenseCo, NTI or HoldCo by virtue of his or her voting or financial stake  
in LicenseCo, NTI or HoldCo.

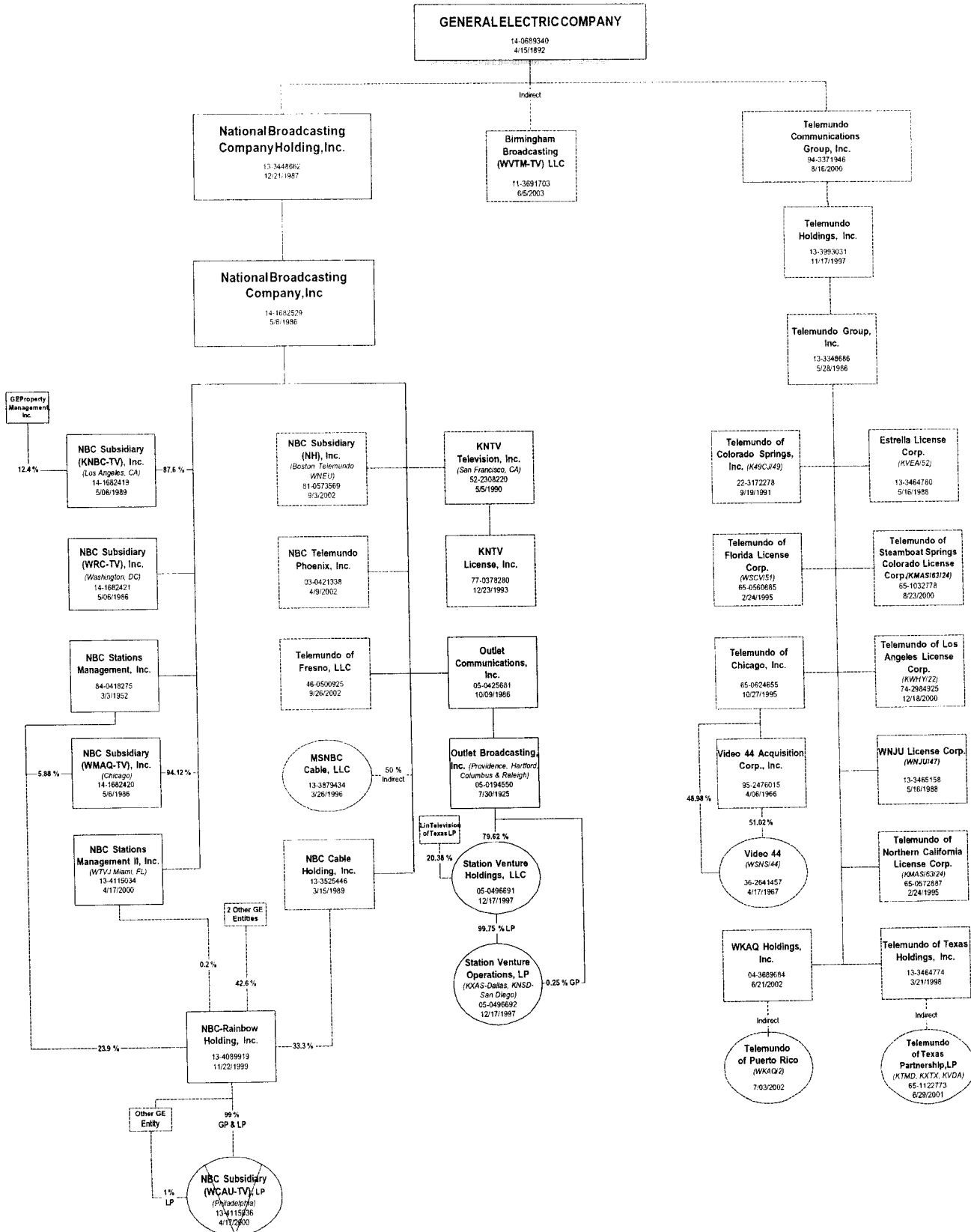

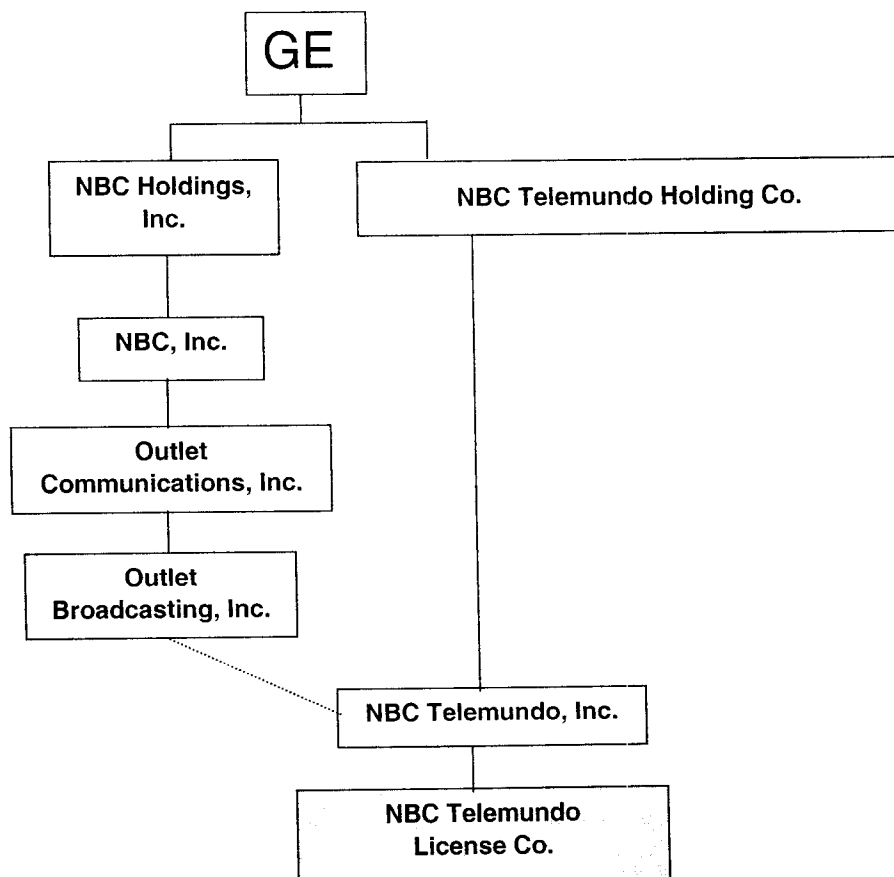
