

Exhibit 5 – Compliance with Local Radio Ownership Rule

The Sentinel Publishing Co., the licensee of WDHA-FM, Dover, New Jersey, is an indirect, wholly-owned subsidiary of Greater Media, Inc. (“Greater Media”).

For purposes of the local radio ownership rule, WDHA-FM is deemed to be a part of the Morristown, New Jersey Arbitron Metro. WDHA-FM is licensed to Dover, New Jersey, Morris County, which in turn is located in the Morristown, New Jersey Metro, as defined by Arbitron. The attached exhibit was compiled on March 14, 2007 using BIA Research, Inc.’s *Media Access Pro* database. The exhibit lists all radio stations, including WDHA-FM, that are licensed to communities within the counties comprising the Morristown, New Jersey Metro or that Arbitron designates as “home” to that Metro. As demonstrated in the exhibit, there are 6 stations in the Morristown, New Jersey Metro, as so defined. Under the local radio ownership rule, a person or single entity (or entities under common control) in a radio market with 14 or fewer full-power, commercial and noncommercial radio stations may have a cognizable interest in up to 5 commercial radio stations (not more than 3 of which are in the same service (AM or FM)), except that a party may not have a cognizable interest in more than 50% of the total number of full-power commercial and noncommercial stations in such a market; provided that an attributable interest in one AM/FM combination in the Metro is permissible without regard to this 50% limitation.

As shown in the exhibit, Greater Media controls 2 radio stations in the Morristown, New Jersey Metro (1 AM and 1 FM), including WDHA-FM, which fully complies with the local radio ownership rule.
