TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared on behalf of Apex Broadcasting, Inc. ("Apex"). Apex is proposing to make minor changes in the facilities of KBXG, Channel 258C0, Lake Charles, Louisiana. As a result, the city grade contour of the station will change. Apex is also the licensee of radio stations KLCL, 1470 kHz, Lake Charles, Louisiana; KJMH, Channel 298C2, Lake Arthur, Louisiana; KJEF, 1290 kHz, and KHLA, Channel 225C2, Jennings, Louisiana; and KNUF, Channel 221C3, De Ridder, Louisiana.¹ As a result of the relocation of KBXG, the radio market in which Apex has interests is changed. Because of the overlap of contours between the stations, three distinct radio markets are created. Market #1 consists of FM stations KBXG (proposed) and KNUF licensed. Market #2 consists of FM stations KBXG (proposed), KHLA and KNUF (applied for) and AM station KLCL. Market #3 consists of FM stations KBXG (proposed), KHLA and KJMH and AM station KLCL. Exhibit #1 is a map depicting all the Apex stations.

2. A study, therefore, has been conducted to determine if ownership of these facilities complies with §73.3555 of the Commission's rules. Since the proposed KBXG is a subject station in each of the markets, its contour will be used to define the market boundary, hereinafter

referred to as the “Radio Market”. The study will determine the number of other commercial AM and FM stations that either have transmitter sites within, or provide coverage to, the subject radio market. Once this is determined, the subject stations in each of the respective markets will be added to demonstrate compliance with the Commission’s rules.

3. Exhibit #2 is a depiction of the other stations within the KBXG city grade/Radio Market boundary; thirteen commercial AM and FM stations are depicted. Exhibit #3 is a tabulation of the stations in Radio Market #1 [KBXG (proposed) /KNUF (licensed)], a total of fifteen stations, including the subject stations. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.² At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible.

4. Exhibit #4 is a tabulation of the stations in Radio Market #2 [KBXG (proposed), KHLA, KNUF (applied for) and KLCL], a total of seventeen stations, including the subject stations. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.³ At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible.

5. Exhibit #5 is a tabulation of the stations in Radio Market #3 [KBXG (proposed), KHLA, KJMH and KLCL], listing a total of seventeen stations, including the subject stations. The number of stations depicted falls in the fifteen to twenty-nine stations tier of §73.3555(a)(1)(iii) of the Commission's rules.⁴ At the fifteen to twenty-nine stations level, common ownership or control of up to six stations, with no more than four in the same service, is permissible. Based on Apex's interests in the above referenced stations in three separate markets, it is demonstrated herein that the proposed relocation of KBXG is in compliance with the Commission's multiple ownership rules, as detailed in §73.3555 of the rules.

7. The foregoing technical statement was prepared on behalf of Apex Broadcasting, Inc., by Graham Brock, Inc., its Technical Consultants. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities was extracted from the CDBS database. 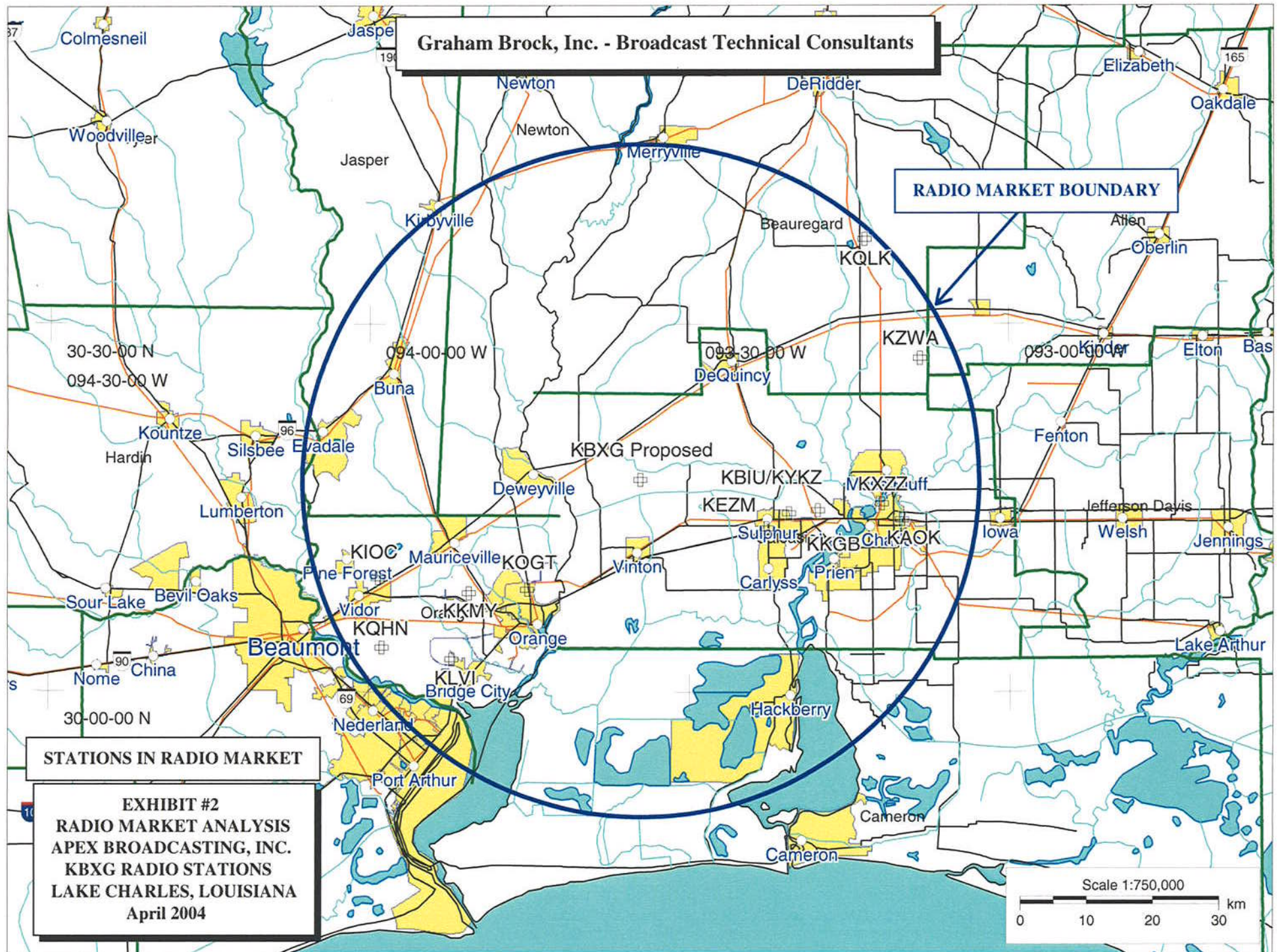


