Contour Protection
KHNA Warren Air Force Base WY

This exhibit will show compliance with contour protection rules under the provisions of section 73.215, towards channel 278C0 allocated to KRFK in Denver CO.

The site proposed, N 41-09-34, W 104-43-19 will meet the minimum separation requirements under 73.215 toward KRFK. The minimum separation under 73.215 between the proposed Class C2 operation on channel 277 and the class C0 operation on channel 278 is 163 km. The actual distance between the proposed KHNA location and the KRFK licensed location, N 39-43-59 W 105-14-10 is 164.3 km.

The proposed KHNA location and KRFK were evaluated for contour overlap. First, KRFK is not licensed under section 73.215, so was adjusted for operation at its potential maximum class C0 facilities at the licensed coordinates.

It is proposed to operate KHNA with an effective radiated power of 37 kilowatts with an antenna height above average terrain of 78 meters.

Figure 1 shows the contours of KRFK operating at maximum facilities and the proposed operation of KHNA on channel 277C2 utilizing the specified directional antenna. There is no prohibited overlap.

It was concluded that the proposed operation of KHNA on channel 277C2 at the location specified will meet all of the provisions under section 73.215 of the Commission rules.

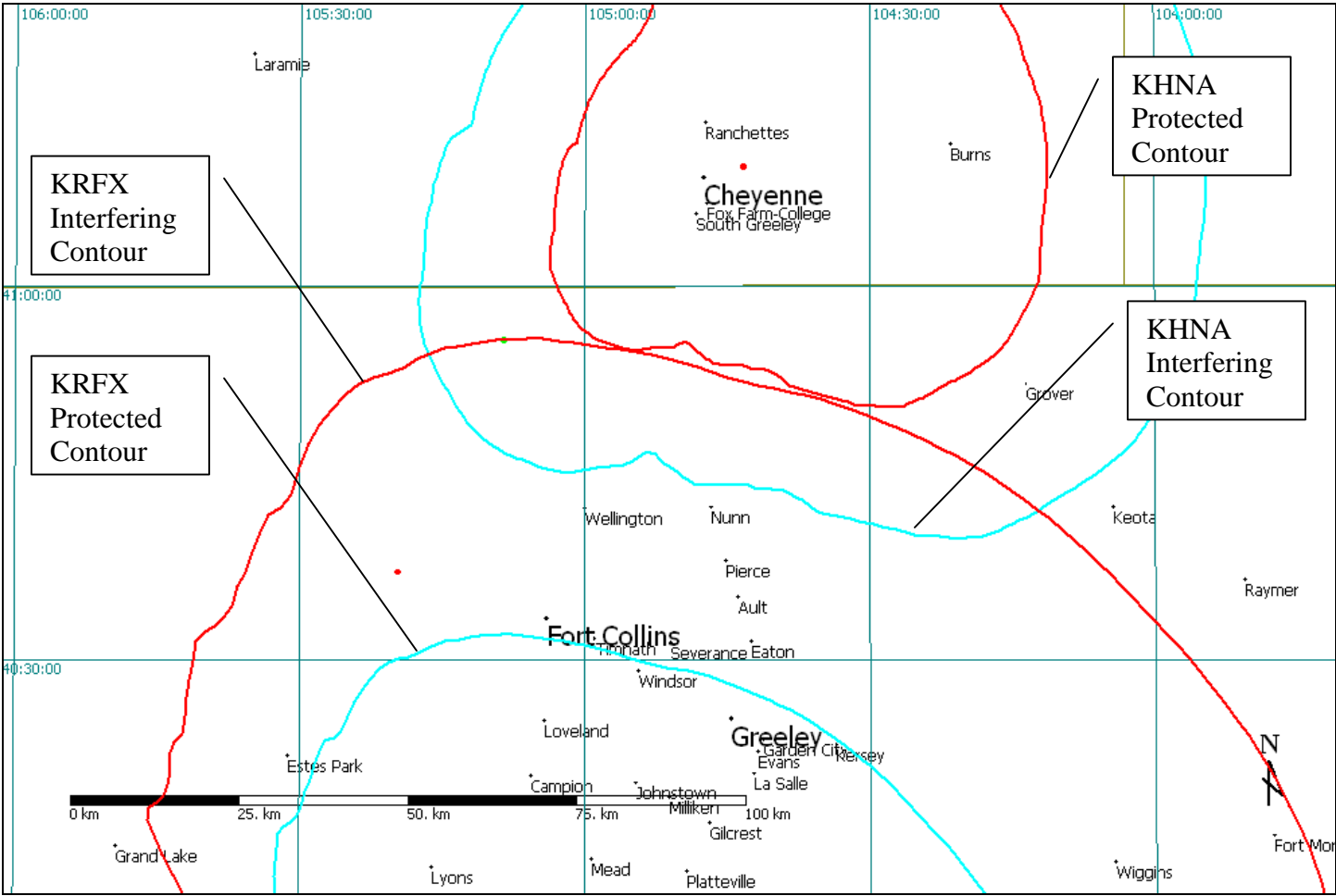
