Agreements for Sale of Station

Tri-City Radio, LLC, the assignor, and ASRadio, LLC, the assignee, have entered into an Asset Purchase and Sale Agreement executed on March 11, 2005, providing for the assignment of the license for radio broadcast station WEYE(FM). The same parties have also entered into a Time Brokerage Agreement, Escrow Agreement (also with Wilmington Trust Company, as the Escrow Agent), and Real Estate Sales Agreement, all executed on March 11, 2005. In addition, the Asset Purchase and Sale Agreement includes a Guaranty by American Media Services, LLC. The Escrow Agreement, Real Estate Sales Agreement, and Guaranty are not included with this application nor are being placed in the station's public inspection file as they contain information that is not germane to the FCC's or public's review of the proposed transaction.

Except as noted below, complete copies of the Asset Purchase and Sale Agreement and the Time Brokerage Agreement are attached and are being placed in the station's public inspection file. Confidential information regarding payment in the Time Brokerage Agreement has been redacted from the application and public file copies. The schedules to the Asset Purchase and Sale Agreement have been omitted from the application and public file copies as they contain proprietary information and are not germane to the FCC's or public's review of the proposed transaction. Copies of the schedules will be provided to the Commission upon the Commission's request. The following schedules to the Asset Purchase and Sale Agreement have been omitted from the application, for the reasons noted below:¹
