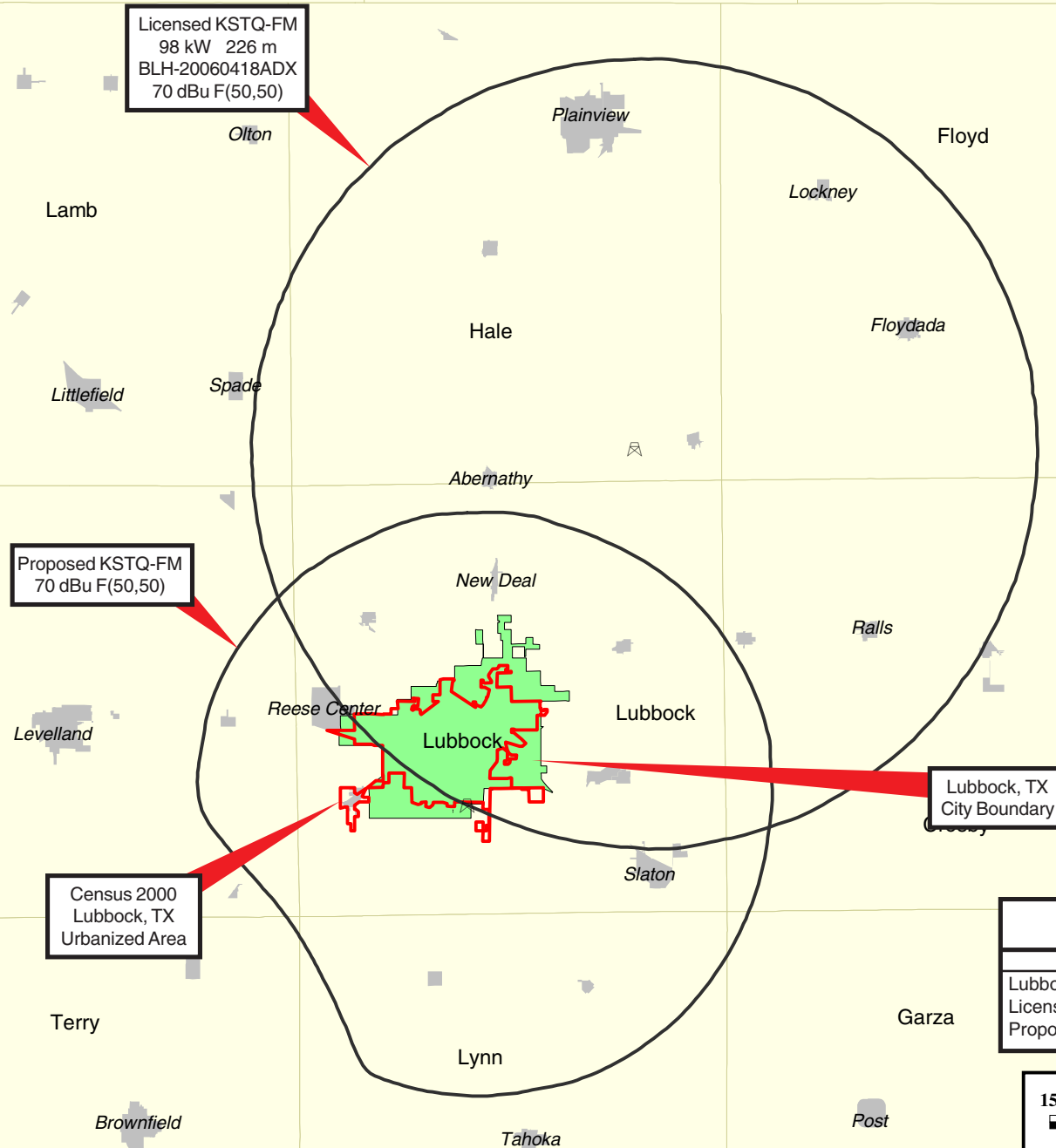

**COVERAGE COMPARISON**

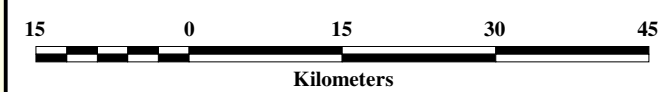
