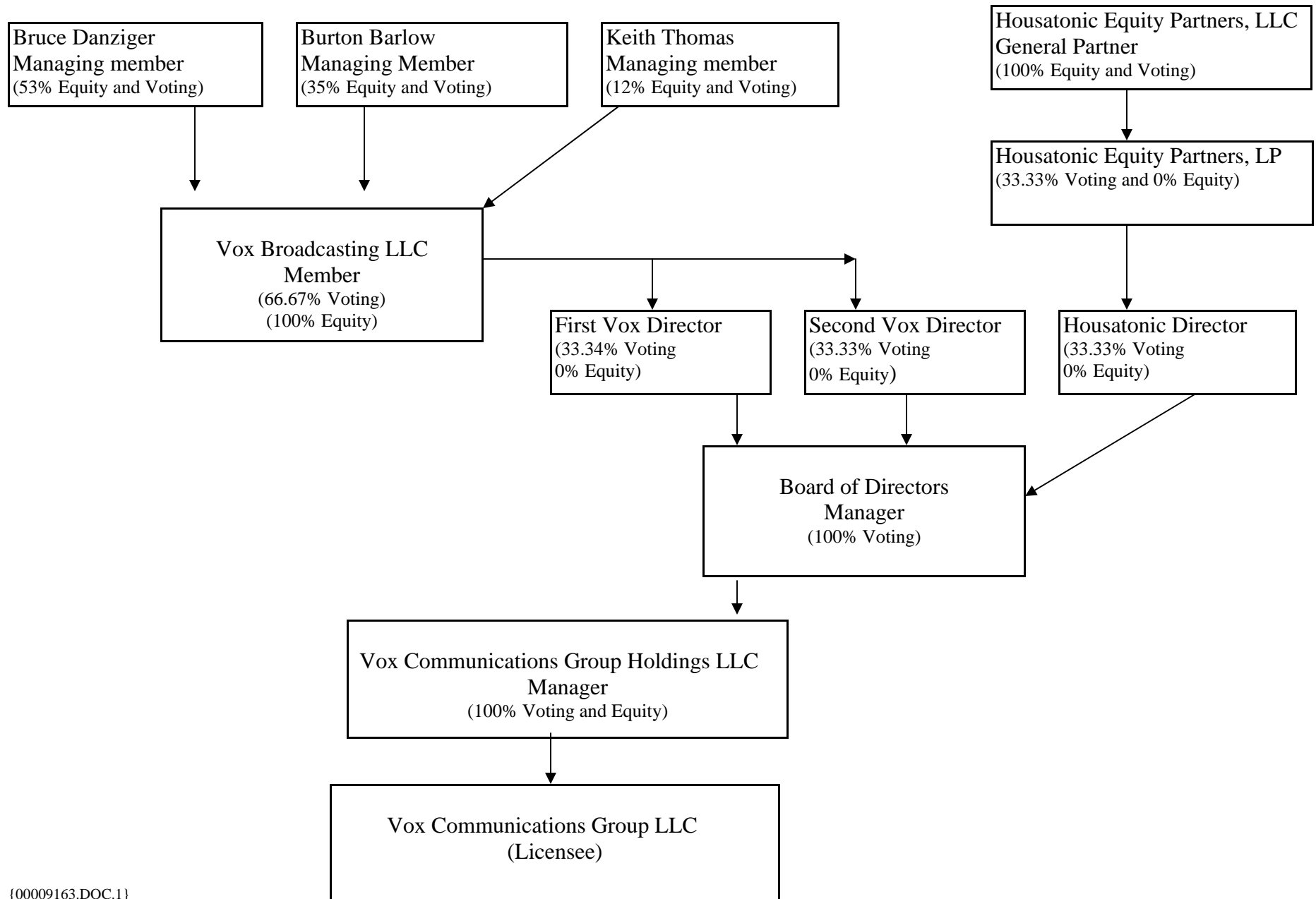


Ownership Structure of Vox Communications Group LLC

Vox Communications Group LLC (“Vox Communications”) is a wholly owned subsidiary of Vox Communications Group Holdings LLC (“Vox Holdings”). Vox Holdings in turn is controlled by a Board of Directors. Vox Broadcasting LLC is controlled by Bruce G. Danziger. The Board of Directors for Vox Holdings has three directors; two appointed by Vox Broadcasting LLC and one by Housatonic Equity Partners, L.P. Housatonic Equity Partners, L.L.C. is the sole general partner of Housatonic Equity Partners, L.P. The ownership structure and voting and equity interests of Vox Communications, Vox Holdings, Vox Broadcasting LLC, Housatonic Equity Partners, L.L.C., Housatonic Equity Partners, L.P. and the Board of Directors are listed below.

Housatonic Equity Partners, LP and Housatonic Equity Partners, LLC have voting rights in the licensee only and do not own any equity. Vox Broadcasting holds 100% of the equity in Vox Communications Group and 67.67% of the voting rights in Vox Communications Group by virtue of the right of Vox Broadcasting to appoint two of the three directors that manages Vox Communications Group. Accordingly, Vox Communications Group holds 100% of the equity and 67.67% of the voting rights in the licensee.
