JPMP Master Fund Manager, L.P., member of Quetzal/J.P. Morgan Partners (GP), LLC, is wholly controlled by JPMP Capital Corp., which in turn is a wholly-owned subsidiary of J.P. Morgan & Chase Co., a publicly traded Delaware corporation with investments and interests in a wide range of companies and industries. JPMP Master Fund Manager, L.P. has limited partners, and JPMP Capital Corp. and J.P. Morgan Chase & Co. have officers and directors, who are technically uninsulated from attribution but have no ability to exercise authority or influence over the day-to-day operation of the Archway Licensees and have no oversight function related in any manner to the Archway Licensees and their stations.
