

**OMITTED SCHEDULES AND EXHIBITS**

The parties to this application executed a Stock Purchase Agreement (the "SPA"), a Local Marketing Agreement (the "LMA"), and an Escrow Agreement, each dated as of July 18, 2012. In making that determination, the Commission assesses an applicant's qualifications based upon the applicant's identity, the identity and qualifications of its owners (if the applicant is not an individual), the alien involvement (if any) in or with the applicant, the applicant's financial qualifications, the other media interests of the applicant and its owners, the character qualifications of the applicant and its owners, and the applicant's and owners' compliance with the Anti-Drug Abuse Act of 1988, 21 U.S.C. §862. The omitted documents contain confidential and proprietary information or other information that is not relevant to those determinations. However, the omitted documents will be made available upon request of the Commission.
