TECHNICAL STATEMENT

1. This technical statement and attached exhibits were prepared in conjunction with a proposed transfer of control of stations WFMS, Channel 238B, Indianapolis, Indiana; WJJK, Channel 283B, Noblesville, Indiana; and WISG, Channel 230A, Fishers, Indiana. WFMS, WJJK and WISG are each authorized in communities within metro counties in the Indianapolis, Indiana Arbitron Market (Market #41). As such, a review of the number of stations in the Indianapolis, Indiana market will be conducted to show the proposed combination is in compliance with the rules.

2. As shown on Exhibit #1, there are forty-one AM and FM (commercial and non-commercial) stations listed in the Indianapolis, Indiana Arbitron Market. The transferee would be in control of three FM stations in the market. The number of stations indicated falls in the thirty to forty-four stations tier of §73.3555(a)(1)(ii) of the Commission's rules. At this level, common ownership or control of up to seven stations, with no more than four in the same service, is permissible. Therefore, the transfer of control of station of WFMS, WJJK and WISG is believed to be in compliance with the Commission's radio ownership rules.

3. The foregoing technical statement was prepared by Graham Brock, Inc. All information contained herein is true and accurate to the best of our belief and knowledge. All data relating to AM and FM facilities in the relevant BIA/Arbitron market was determined using the BIA Financial Network, Inc. Media Access Pro, Version 4.0. BIA database. We assume no liability for errors or omissions in that database which may be adverse to the information contained herein.
